Gentlemen:

In accordance with Section 10 of the Big Eddy Unit Agreement dated April 10, 1952, Bass Enterprises Production Co., Operator of the referenced unit, hereby submits a Plan of Development for the Big Eddy Unit for the year 2004.

HISTORY OF PAST DEVELOPMENT

We refer to our previous Plans of Development for a detailed description of the operations conducted in this Unit in prior years.

2003 ACTIVITY

Big Eddy Unit No. 143 - This well was drilled at a location being 660' FSL, 1,896' FWL, Section 19, T21S-R28E, Eddy County, New Mexico. This well was completed in the Morrow Formation as an oil well in the interval between 12,014' to 12,020'.

Big Eddy Unit No. 144 - This well was drilled at a location being 660' FNL, 710' FWL, Section 30, T21S-R28E, Eddy County, New Mexico. This well was completed in the Morrow Formation as a gas well in the interval between 11,613' to 11,752'.

PARTICIPATING AREAS

Bass Enterprises Production Co. has submitted all wells drilled to date where adequate information is available for commercial determination and participating areas. In the event you have not received commercial determinations for the wells that have been drilled and completed and are currently producing, please advise at your earliest convenience and we will submit same to you.

FUTURE DEVELOPMENT

Big Eddy Unit No. 150 - This well is in the process of being drilled at a legal location being 1,980' FSL, 1,980' FWL, Section 17, T21S-R28E by Nadel and Gussman, as Bass Agent. The proposed total depth is 12,100' to test the Morrow formation.

Big Eddy Unit No. 146 - This well is planned to be drilled at a legal location being 1,980' FNL, 660' FEL, Section 31, T21S-R28E, Eddy County, New Mexico to a total depth of 12,300' to test the Morrow Formation.

Big Eddy Unit No. 149 - This well is planned to be drilled at a legal location being 660' FNL, 660' FEL, Section 32, T21S-R28E, Eddy County, New Mexico to a total depth of 12,500' to test the Morrow Formation.

Big Eddy Unit No. 151 - This well is planned to be drilled at a legal location being 1,650' FNL, 990' FEL, Section 30, T21S-R28E, Eddy County, New Mexico to a total depth of 12,250' to test the Strawn and Morrow Formations.

OFFSET OBLIGATIONS

Appropriate and adequate measures will be taken to prevent drainage of unitized substances from lands within the Big Eddy Unit area, or pursuant to applicable regulations.

MODIFICATIONS

In accordance with the terms and provisions of the Big Eddy Unit Agreement, this Plan of Development may be modified from time to time as a result of changing conditions.

EFFECTIVE DATE

This Plan of Development became effective January 1, 2004.


