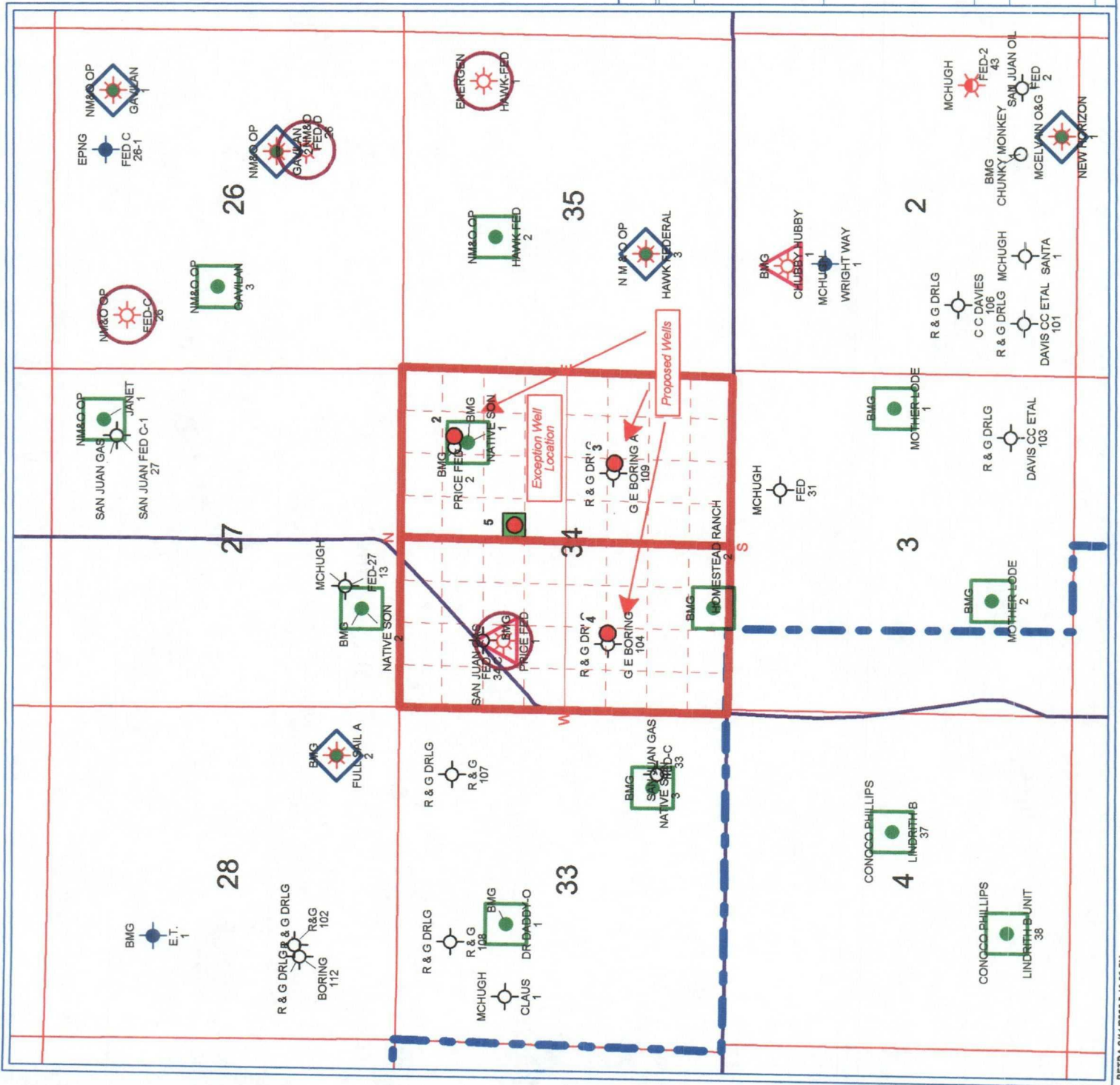


Exhibit 1 - Project Area Map

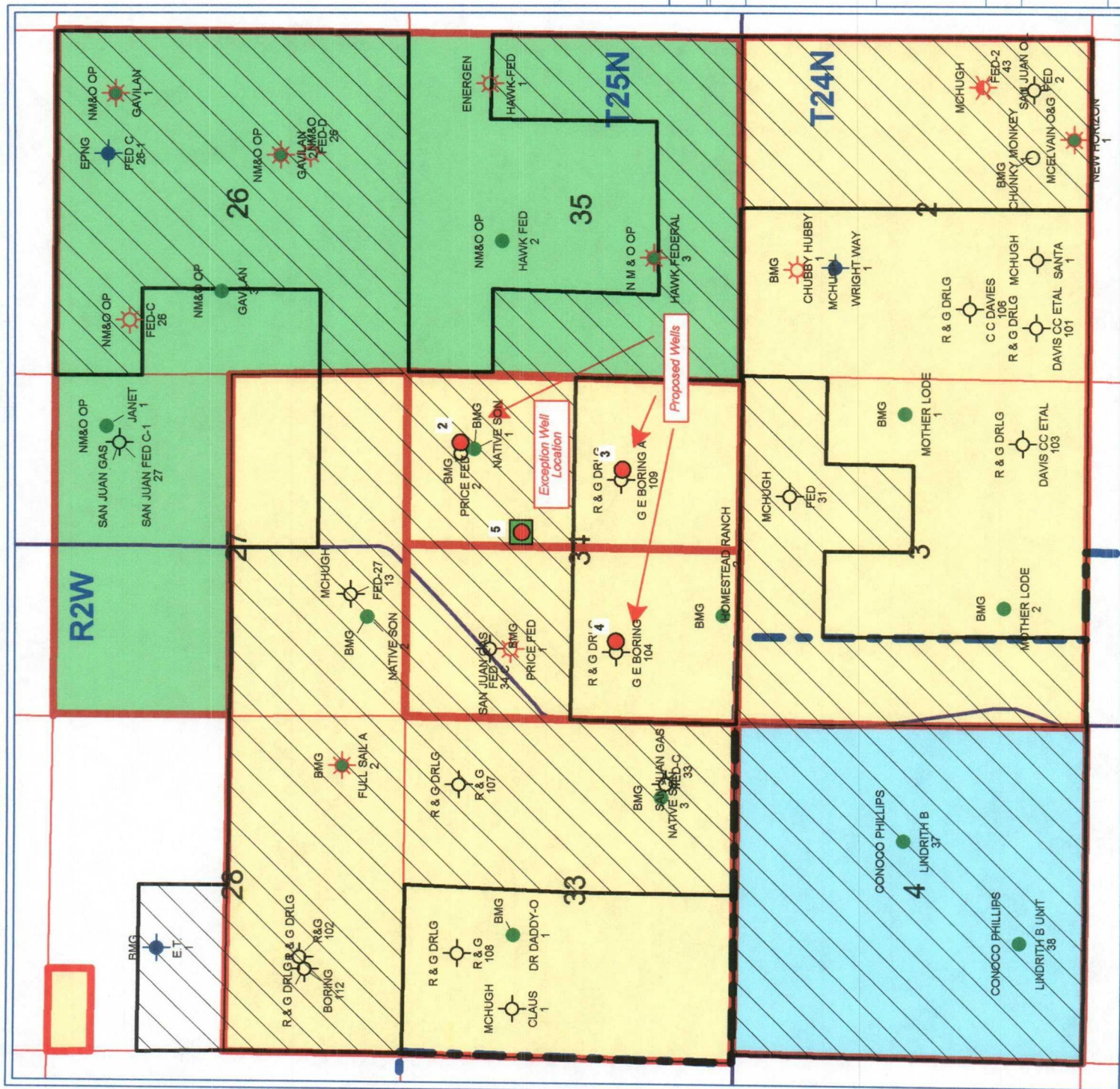
