The unit is to be dedicated to the Alfalfa 32 Fee Well No. 1, to be drilled as a horizontal well. Also to be considered will be the cost of drilling and completing the well and the allocation of the cost thereof, as well as actual operating costs and charges for supervision, designation of applicant as operator of the well, and a 200% charge for the risk involved in drilling and completing the well. The application is scheduled to be heard at 8:15 a.m. on Thursday, January 4, 2007, at the Division's offices at 4220 South St. Francis Drive, Santa Fe, New Mexico 87505. As interest owners in the well unit, you have the right to enter an appearance and participate in the case. Failure to appear will preclude you from contesting this matter in a later date. The attorney for applicant is James Bruce, P.O. Box 1056, Santa Fe, New Mexico 87504. The unit is located approximately 6 miles west-southwest of Lake Arthur, New Mexico.
