
Dear Ms. Cox:

I have been trying to contact you over the last week concerning the above well location on your surface, being 990' from north line and 2310' from west line of the section lines for Section 9. I have enclosed a plat indicating the location of the well. I wish to talk to you about moving the location south into the 5 acre tract on the south end of your property. This will be less overall inconvenience for you and not interrupt the continuity of your tract.

I know the last time we talked you did not want to have a well on your land, but I have talk to the company and check the surface area and the south part of your land is the best location to cause less disruption and is the best location geologically. The State retained the rights to drill on the land when they sold the land to private sector, so I wish to try to work something our with you. As I stated on the telephone, if you do not wish to discuss this with me, I will be glad to communicate with your attorney, if you will have him call me at 505-420-2419 or give me his name to contact.

I advised you with my message on the telephone today, Quest needs to survey the location this week to be able the fulfill the agreement with the State, so if I do not here from you, Quest will contract a Survey Company to survey the location as it stands. So you can see why it is so important we make contact very soon. I look forward to hearing from you or your attorney as soon as possible.

Dear Mr. Williams,

This letter is to raise an objection and to request a hearing on the proposed location of the Quest Resource Corporation well in the above-described Section 9. So far it is unclear whether an application to drill (OCD Form C-101 or a location Form C-102) have been filed. The basis for the objection is the proximity of the proposed well to homes, a school (Stone Elementary) and a retirement home. The financial assurance bonding for this location should be reviewed to make sure it is adequate under OCD Rule 19.15.3.101. At the very least this application should be reviewed so as to ensure that all appropriate precautions are taken for the safety of persons and property in the areas pursuant to OCD rule 19.15.1.102(D). As you are aware in the last several years blowouts have occurred in wells located west of Lovington and on the south side of Carlsbad. A similar occurrence at this location could be devastating.

Please set this matter for hearing before approval is given.


