

POLICIES GOVERNING THE PROVISION OF ADOPTION SERVICES, MATCHING TO SUBSTITUTE CARE, AND RECRUITMENT OF FOSTER CARE PROVIDERS

The Protective Services Division of the Children, Youth and Families Department will hold a public meeting on October 16, 1995, beginning at 9:00 o'clock a.m. in the Apodaca Conference Hall, 2nd floor PERA Building, 1120 Paseo De Peralta, Santa Fe, New Mexico, to consider its proposed amendments to policies governing the Division's provision of adoption services, matching to substitute care, and recruitment of foster care providers. This conference room is handicap accessible through entry on the East side of the building.

The purpose of these policies is to delineate the Department's role and responsibility in providing adoption services to children in the Department's custody, prevent discrimination in the placement of children in foster care or adoptive homes on the basis of race, color, or national origin, and facilitate the diligent recruitment of foster and adoptive parents. These proposed policy amendments: clarify the purpose, goal, eligibility, Department responsibilities, service provision and related regulations for the provision of adoption services; specifies factors the Department shall consider in selecting a substitute care placement; and, states the Department's policy on the recruitment of foster parents.
