

**ORDER GRANTING AMENDED MOTION TO SUSPEND PROCEEDS**

THIS MATTER came before the Court on January 11, 2007, at 11:30 a.m. on the Amended Motion of Jerry T. Walmsley, trustee of the June Walmsley Bypass Trust under the will of June H. Walmsley dated April 7, 1992 ("Walmsley"), to require that Synergy Operating, LLC suspend all proceeds attributable to the disputed interests in the Duff 104 and Duff 105 wells. Walmsley appeared telephonically through his attorneys, Sutin Thayer & Browne A Professional Corporation (Derek V. Larson). Synergy Operating, LLC appeared through its attorneys, Finch & Olson, P.A. (Kyle M. Finch). The Kurtz Defendants appeared telephonically through their attorneys, Dixon,

Scholl & Bailey, P.A. (Gerald G. Dixon). The Court, having reviewed the memoranda, hearing oral argument from the parties and being otherwise fully advised in the premises, finds and orders:

1. The Amended Motion to Suspend Proceeds is granted. Synergy Operating, LLC, shall place all of the proceeds attributable to all of the interests in the Duff Wells beginning as of the date of entry of this Order into an interest bearing bank account;
2. Such deposits shall not be withdrawn from the account for any reason except by order of the Court;
3. At no time shall the balance of the account fall below the total of all deposits made, except by order of the Court,
4. Synergy Operating, LLC shall provide all parties to this lawsuit with written proof of each deposit and all account activity no later than the 25<sup>th</sup> of each month.
5. All motions for summary judgment in this case shall be filed by February 12, 2007.
