PURPOSE: The purpose of this subpoena is to provide all of the information necessary for OXY USA WTP – Limited Partnership to be able to prepare its evidence and testimony for New Mexico Oil Conservation Division Case 13877 (De Novo).

PRODUCE THE FOLLOWING DOCUMENTS:

For the Checker State Well No. 2 that Bold Energy, LP (hereinafter referred to as “Bold”) proposes to drill in the SW/4 NW/4 of Section 8, Township 19 South, Range 29 East, NMPM, Eddy County.

- (1) Any and all documents, including all draft documents, concerning Bold’s efforts to develop these lands, including but not limited to all well proposals, drafts and signed agreements, e-mails and letters. This Subpoena specifically includes but is not limited to all documents concerning the termination of the Letter Agreement dated March 27, 1997 covering Sections 8 and 9 of Township 19 South, Range 29 East, NMPM, Eddy County, New Mexico between Threshold Development Company et al. (hereinafter referred to as “Letter Agreement”) and the Stipulation of Interests covering the ownership of oil and gas interests in the area covered by this Stipulation of Interests.
- (2) All Engineering and geological data relied upon by Bold in proposing to drill this well at this location and to the proposed depth.
- (3) Copies of all exhibits that Bold proposes to offer at the Commission hearing in this case.

INSTRUCTIONS

This Subpoena Duces Tecum seeks all information available to you or in your possession, custody or control from any source, wherever situated, including but not limited to information from any files, records, computers documents, employees, former employees, consultants, counsel and former counsel. It is directed to each person to whom such information is a matter of personal knowledge.

When used herein, "you" or "your" refers to the persons and entity to whom this Subpoena Duces Tecum is addressed to including all of his or its attorneys, officers, agents, consultants, employees, directors, representatives, officials, departments, divisions, subdivisions, subsidiaries, or predecessors in interest.
