

APPLICATION

Devon Energy Production Company, L.P. applies for an order approving five non-standard gas spacing and proration units, and in support thereof, states:

1. Applicant is the operator of the Northeast Blanco Unit, which covers over 30,000 acres of land in San Juan and Rio Arriba Counties, New Mexico.

2. Applicant requests approval of the following non-standard gas spacing and proration units for production from the Basin-Dakota Gas Pool:

- (a) Township 31 North, Range 7 West, N.M.P.M.
Section 19: Lots 5-8 and E $\frac{1}{2}$ W $\frac{1}{2}$
Section 30: Lot 5 and NE $\frac{1}{4}$ NW $\frac{1}{4}$

Containing 259.82 acres, in San Juan County. This acreage was approved as a non-standard unit for production from the Blanco-Mesaverde Gas Pool by Commission Order No. R-749.

- (b) Township 31 North, Range 7 West, N.M.P.M.
Section 30: Lots 6, 9, 10, SE $\frac{1}{4}$ NW $\frac{1}{4}$ and E $\frac{1}{2}$ SW $\frac{1}{4}$
Section 31: Lots 7, 8, and E $\frac{1}{2}$ NW $\frac{1}{4}$

Containing 250.65 acres, in San Juan County. This acreage was approved as a non-standard unit for production from the Blanco-Mesaverde Gas Pool by Commission Order Nos. R-750 and R-750-A.

- (c) Township 31 North, Range 7 West, N.M.P.M.
Section 31: Lots 11, 12, and E $\frac{1}{2}$ SW $\frac{1}{4}$

Township 30 North, Range 7 West, N.M.P.M.

Containing 296.02 acres, in San Juan County. This acreage was approved as a non-standard unit for production from the Blanco-Mesaverde Gas Pool by Commission Order No. R-751.

Section 7: Lots 6-9, 12-15, and 38.52 acres out of Tract 40
Section 18: Lots 7, 8, and $E\frac{1}{2}NW\frac{1}{4}$

Containing 298.90 acres, in San Juan County. This acreage was approved as a non-standard unit for production from the Blanco-Mesaverde Gas Pool by Commission Order No. R-752.

- (e) Township 30 North, Range 7 West, N.M.P.M.
Section 18: Lots 12, 13, and $E\frac{1}{2}SW\frac{1}{4}$
Section 19: Lots 6, 7, 12, 13, and $EW\frac{1}{2}$

Containing 307.44 acres, in San Juan and Rio Arriba Counties. This acreage was approved as a non-standard unit for production from the Blanco-Mesaverde Gas Pool by Commission Order No. R-753.

3. The granting of this application will prevent waste and protect correlative rights.

WHEREFORE, applicant requests that, after notice and hearing, the Division enter its order granting the relief requested above.
