7 the last case on the docket. It's Cause Number 13,531,  
8 continued from the March 16th, 2007, Commission meeting.  
9 It is the Application of Yates Petroleum Corporation for an  
10 order, 1), directing Pride Energy Company to reimburse  
11 Yates for the well costs incurred by Yates in its attempt  
12 to re-enter the State X Well Number 1, located in Section  
13 12, Township 12 South, Range 34 East, NMPM, prior to the  
14 time Pride Energy assumed operations of the well, and 2),  
15 directing Pride Energy Company to account for and pay all  
16 sums it is now improperly holding pursuant to the expired  
17 order of the Division and Commission, and 3), requiring  
18 Pride Energy to plug and abandon the State X Well Number 1  
19 in Lea County, New Mexico.

20           This case has been continued to the May 17th,  
21 2000, Commission Hearing at the request of counsel.

22           Is there anything further before the Commission

24           COMMISSIONER OLSON: Just a question, I guess.  
25 So we're going to have a rehearing on Samson-Chesapeake,

13 COMMISSIONER OLSON: Okay.

14 CHAIRMAN FESMIRE: Is there anything else before  
15 the Commission today?

16 MS. BADA: And the -- I should also say, the  
17 reason we granted that, or that I advised we grant it, is  
18 because there was no notice on that 160 in the northwest  
19 quarter.

20 COMMISSIONER OLSON: Right.

21 CHAIRMAN FESMIRE: And we felt it necessary to --

22 COMMISSIONER OLSON: Right.

23 CHAIRMAN FESMIRE: -- to allow them notice on  
24 that.


