**JUDGMENT OF QUIET TITLE**

THIS CAUSE having come before the Court:

PARTIES APPEARING

9. The mineral rights which are the subject matter of this suit are in Chaves County to wit:

**3/4 only of the minerals underlying NE1/4 of Section 7, N1/2 SW1/4 and S1/2 NW1/4 of Section 8, Township 15 South, Range 25 East, N.M.P.M.**

10. All parties of record are in agreement as to this Judgment.

11. Defendant, Opal Norris, has paid her proportionate share of Plaintiff's attorney's fees and costs prior to this Agreed Judgment of Quiet Title being entered herein.

12. Defendants, Lloyd Earl Hatch, Mary Lee Davis, Joyce Fansler and Ernie Smith, shall pay their proportionate share of Plaintiff's attorney's fees and costs within five (5) days of this Agreed Judgment of Quiet Title being entered herein.

16. Title is quieted to the 3/4 mineral interest underlying the above described lands as the parties' sole and separate property as set forth in *Exhibit A*.


17. All persons' respective title to the 3/4 mineral interest is forever quieted against the unknown heirs and unknown claimants.
