





APPLICATION

Beach Exploration, Inc. ("Beach"), whose address is Suite 200, 800 North Marienfeld, Midland, Texas 79701, applies for an order approving a waterflood project and qualifying the project for the recovered oil tax rate. In support thereof, Beach states:

1. Beach is the operator of the proposed Eastland Queen Unit Area (the "Unit Area"), which covers the following lands located in Eddy County, New Mexico:

Township 19 South, Range 29 East, N.M.P.M.

Section 1: N $\frac{1}{2}$, N $\frac{1}{2}$ SW $\frac{1}{4}$, SW $\frac{1}{4}$ SW $\frac{1}{4}$, and NW $\frac{1}{4}$ SE $\frac{1}{4}$
Section 2: SE $\frac{1}{4}$ NE $\frac{1}{4}$, SE $\frac{1}{4}$ SW $\frac{1}{4}$, and SE $\frac{1}{4}$
Section 11: N $\frac{1}{2}$

Containing 1,040.00 acres of state lands.

The unitized interval is the Queen Sand, as further described in the unitization application filed concurrently with this application.

2. Beach proposes to institute a waterflood project in the Unit Area.
3. Beach proposes to inject water into the Queen Sand from approximately 18 existing or planned wells. A plat outlining the Unit Area, and marking the locations of the injection and producing wells, is attached hereto as Exhibit A. A listing of the injection wells is attached as Exhibit B.


4. Beach requests that the waterflood project for the Unit Area be qualified for the recovered oil tax rate, pursuant to the Enhanced Oil Recovery Act (L. 1992, ch. 38) and Division regulations. Project data includes:

- (a) Number of producing wells: 12
- (b) Number of injection wells: 18
- (c) Capital cost of additional facilities: \$2,475,000.00
- (d) Estimated total project cost: \$2,500,000.00
- (e) Estimated value of incremental production: \$21,000,000.00
- (f) Estimated injection commencement date: November 2007
- (g) Type of injected fluid: Produced and fresh water
- (h) Anticipated injection volumes: 150 BWPD/well

5. The Form C-108 for the project is attached hereto as Exhibit C. *← See Hearing EXHIBIT*
6. Approval of this application will prevent waste and protect correlative rights.

WHEREFORE, Beach requests that, after notice and hearing, the Division enter its order approving the injection application, and qualifying the project as an Enhanced Oil Recovery Project.


