Ladies and Gentlemen:

The above referenced Application was filed regarding the Subject location for drilling. As officials representing the citizens, residents, and property owners of the effected area of Farmington, San Juan County, New Mexico, you are first responsible to protect those whom you represent. As a citizen, resident, and property owner in the close vicinity of the proposed drilling, please allow me to share my concerns and the concerns of many of my neighbors.

As a native and resident of petroleum producing areas of New Mexico for over 61 years, I have never heard of the McElvain organization nor have I heard of the approach they have taken in the above matter. Initially, the property owners were approached with a Certified mailing early this year offering the sum of approximately \$50 to compensate for their mineral rights to reopen an existing well near the intersection of 30th and Butler Avenues, not far from downtown Farmington. This is a relatively high-density residential and light commercial area. Directly north of that site and at the northwest corner of the intersection is a rather large apartment complex housing over 150 people. Many of us property owners were not excited by the proposition, and did not opt for the small compensation.

Subsequent to that, McElvain's attorneys sent another Certified mailing, apparently only to those who had not accepted the mineral rights offering. This would indicate that those who had accepted compensation for mineral rights had surrendered all rights regarding new drilling. That may be a legally binding position; however, those who had accepted the reopening of the old well were confused and not happy that they seemingly had no voice in future drilling in the neighborhood. The second Certified mailing of August 31, 2007, proposed drilling a new well called "Ruby No. 1" in the Subject area and offered recipients the opportunity to be a partner in the drilling of that well. According to the mailing, the well would be drilled to a depth of 1,672' at a projected cost of \$958,900 and participants could buy an estimated .07125% interest in the well for \$683.22. No mention, of course, is a standard provision of partnership law that if additional cost was incurred, all partners would have to participate in their shares of that cost or forfeit their

entire equity in the partnership venture. This could be fairly anticipated, as there are very few, if any, producing wells in the area with so shallow a depth as 1,672'. In all of my years around oilfields in southeastern and northwestern New Mexico, I have never seen or heard of such a proposal. I question the credibility of the McElvain Partnership and their proposal. Maybe I have been exposed too much to highly capitalized and highly credible companies such as Conoco/Phillips, BP, Chevron, and others.


Besides these significant issues, the concern of the neighborhood is that the drilling is in a high-density residential area within the City Limits of Farmington. My home is approximately one-quarter mile from the proposed site. In the event of an explosion during the drilling, development, or production of the well, my life and home could be destroyed in an instant, along with many other lives and many other homes. Most of my neighbors and I believe that this is not the appropriate place for energy development. This neighborhood is full of children and adults of all ages who would find their lives at risk. Their homeowner insurance premiums could be expected to increase because of this risk. In addition, the quiet tranquility of this neighborhood would cease to exist due to the noise caused by the drilling equipment and later by the pumping equipment.

Besides the Ruby No. 1 well, it is rumored that McElvain is planning two more wells in the area, based upon mailings some of the property owners have received. This would further magnify the problems defined above.

Attached are petitions that have been signed by a relatively small percentage of residents in my neighborhood. These petitions were limited by the time available to prepare and circulate them. The residents are busy with jobs, children in school or are old and unable to become actively involved. As I spent approximately 2 hours and walked around only one block, I had over 80% sign the petition I carried. I believe that fairly represents the sentiment of the residents affected. Of the other 20%, most were oilfield employees who were afraid that their employer would learn of their sentiment, and that it would negatively effect their employment.

Before you approve this Application filed by McElvain, I respectfully request that you send a large and competent staff to circulate within the neighborhood affected to determine how the total population at risk really feels about the proposed drilling. Neither my neighbors nor I oppose energy development. The economies of San Juan County and Farmington are prospering and dependent upon energy development. This is simply not the place for it. Please do not act too quickly on the Application without considering and investigating these concerns.

This letter is to advise you that McElvain Oil & Gas, Inc. has filed the enclosed application with the New Mexico Oil Conservation Division seeking approval of a an order pooling all uncommitted mineral interests in all formations from the surface to the base of the Pictured Cliffs formation underlying the SW/4 of Section 3, Township 29 North, Range 13 West, N.M.P.M., San Juan County, New Mexico to form a standard 160-acre gas spacing and proration unit for all formations and/or pools developed on 160-acre spacing within that vertical extent, which includes but is not limited to the Fulcher Kutz - Pictured Cliffs Gas Pool.

This application has been set for hearing before a Division Examiner at 8:15 a.m. on October 18, 2007. The hearing will be held in Porter Hall in the Oil Conservation Division's Santa Fe Offices located at 1220 South Saint Francis Drive, Santa Fe, New Mexico, 87505. You are not required to attend this hearing, but as an owner of an interest that may be affected by this application you may appear and present testimony. Failure to appear at that time and become a party of record will preclude you from challenging the matter at a later date.

Parties appearing in cases are required by Division Rule 1208.B to file a Pre-Hearing Statement with the Oil Conservation Division's Santa Fe office, four days in advance of a scheduled haring, but at least on the Thursday preceding the hearing. This statement must include: the names of the parties and their attorneys; a concise statement of the case; the names of all witnesses the party will call to testify at the hearing; the approximate time the party will need to present its case; and identification of any procedural matters that are to be resolved prior to hearing.

APPLICATION

McELVAIN OIL & GAS PROPERTIES, INC. ("McElvain"), through its undersigned attorneys, hereby makes application pursuant to the provisions of N.M.Stat. Ann. 70-2-17 (2007), for an order pooling all uncommitted mineral interests in all formations from the surface to the base of the Pictured Cliffs formation underlying the SW/4 of Section 3, Township 29 North, Range 13 West, N.M.P.M., San Juan County, New Mexico to form a standard 160-acre gas spacing and proration unit for all formations and/or pools developed on 160-acre spacing within that vertical extent, which includes but is not limited to the Fulcher Kutz - Pictured Cliffs Gas Pool. In support of this application McElvain states:

1. McElvain is a working interest owner in the SW/4 of said Section 3 and has a right to drill thereon.
2. McElvain proposes to dedicate the above-referenced spacing or proration unit to its Ruby Well No. 1 to be drilled as vertical well at standard gas well location 1755 feet from the South line and 860 feet from the West line to a depth sufficient to test any and all formations to the base of the Pictured Cliffs formation.
3. McElvain has sought and been unable to obtain a voluntary agreement for the development of these lands from the interest owners identified on Exhibit A to this application.
4. Said pooling of interests will avoid the drilling of unnecessary wells, will prevent

waste and will protect correlative rights.


5. In order to permit McElvain the opportunity to obtain its just and fair share of the oil and gas underlying the subject lands, all mineral interests should be pooled, and McElvain Oil & Gas Properties, Inc. should be designated the operator of the well to be drilled.

WHEREFORE, McElvain requests that this application be set for hearing before an Examiner of the Oil Conservation Division on October 18, 2007, and, after notice and hearing as required by law, the Division enter its order:

- A. pooling all mineral interests in the subject spacing and proration unit,
- B. designating McElvain operator of the unit and the well to be drilled thereon,
- C. authorizing the recovery of McElvain's costs to drill, equip and completing this well,
- D. approving the actual operating charges and costs of supervision while drilling and after completion, together with a provision adjusting the rates pursuant to the COPAS accounting procedures, and
- E. imposing the 200% risk penalty provided by Division Rule 19.15.1.35 against any working interest owner who does not voluntarily participate in the drilling of this well.
