On September 1, 2006 the Northeast Blanco Unit 1st thru 22nd expansions for the Dakota formation was submitted to our office for approval. The approval for this expansion was accomplished on September 15, 2006. Then on August 16, 2007 the Northeast Blanco Unit 23rd thru 25th expansions for the Dakota formation was submitted to our office for approval. The approval for this expansion was accomplished on October 10, 2007. The submission of these expansions caused the following Communitization Agreements (CA) to become obsolete due to the inclusion into the Dakota participating area.

These agreements communitized particular acres of Federal lands within the Northeast Blanco Unit (NEBU) as to natural gas and associated liquid hydrocarbons producible from the Dakota formation. The term of the agreements was for 2 years and for so long thereafter as communitized substances are produced in paying quantities.

Our records indicate that the wells dedicated to the described agreements were completed and that the public interest requirement for the communitization agreements, pursuant to 43 CFR 3105.2-3, have been met.

The termination effective date of these CA's are the effective date of the Participating Area expansion indicated next to each CA. All subject Federal leases involved with these CA's are held by the Unit. All indicated wells will report to 892000929C (Dakota participating area for Northeast Blanco Unit) from effective termination date of the CAs.
