Application of Chesapeake Operating, Inc. for rescission of the Special Rules and Regulations for the T-V Pennsylvanian Pool, Chaves County, New Mexico. Applicant seeks rescission of the Special Rules and Regulations for the T-V Pennsylvanian Gas Pool to permit the pool to be developed under the current General Rule 104.C(2) for deep gas that provides for 320-acre spacing units with wells located no closer than 880 feet from the outer boundary of the quarter section on which the well is located and no closer than 10 feet to any quarter-quarter section line or subdivision inner boundary. 
