BRUCE: Yeah, we can, Mr. Examiner. 7 EXAMINER JONES: Let's combine Case -- Let's call 8 Case 13,997, Application of Pride Energy Company for 9 compulsory pooling, Lea County, New Mexico, and Case Number 10 13,998, Application of Pride Energy Company for compulsory 11 12 pooling, Lea County, New Mexico. Call for appearances in each one of these two 13 14 cases. 15 MR. BRUCE: Mr. Examiner, Jim Bruce of Santa Fe, representing the Applicant. I have no witnesses, I'm 16 presenting them both by affidavit. 17 EXAMINER JONES: No other -- other appearances? 18 MR. BRUCE: I'll first do 13,997, which is the 19 force pooling of the north half of Section 24. 20 Please note that if you turn to Exhibit 1, the 21 landman's affidavit, the only two people being pooled are 22 Dorothy Mae Fann and Doris Fleming. All of the others have 23 come to terms with Pride Energy. 24 25 The usual attachments are made.

This is all -- the north half of 24 is an undivided fee tract, and so although there are four different units sought, the interest ownership in each unit is exactly the same.

And I've submitted -- and the only two people being pooled, Dorothy Mae Fann and Doris Fleming, are unlocatable.

And submitted as Exhibit 2 is an affidavit of publication against those two people.

In Case 13,998, force pooling of the east half of adjoining Section 25, is requested -- it's virtually an identical matter.

And again, the only two people who are being pooled are Dorothy Mae Fann and Doris Fleming. Again, they are unlocatable.

All the other people, the Barton interests, have -- and the Yates Petroleum Interests have leased or farmed out.

And the -- submitted as Exhibit 2 is an affidavit of publication against the two parties being pooled. And I just request that they be -- that those parties be pooled and that this matter be taken under advisement.

EXAMINER JONES: Okay. In Case 13,997 we'll admit Exhibits 1 and 2, and we'll take that case under advisement.
