Gentlemen:

Pursuant to the provisions of Section 11(a) of the San Juan 32-9 Unit Agreement, #14-08-001-569, approved, June 26, 1953, Burlington Resources Oil & Gas Company LP, as Operator, has determined that the well listed is capable of producing unitized substances in paying quantities from the Dakota Formation. Burlington is seeking confirmation of the paying well determination enclosed. Burlington's original letter dated October 10, 2007 listed the well as being commercial. Due to an error on the production allocation percentage, the BLM requested a revised commerciality determination. The #50B well is now showing a negative net present value making it a non-commercial well.

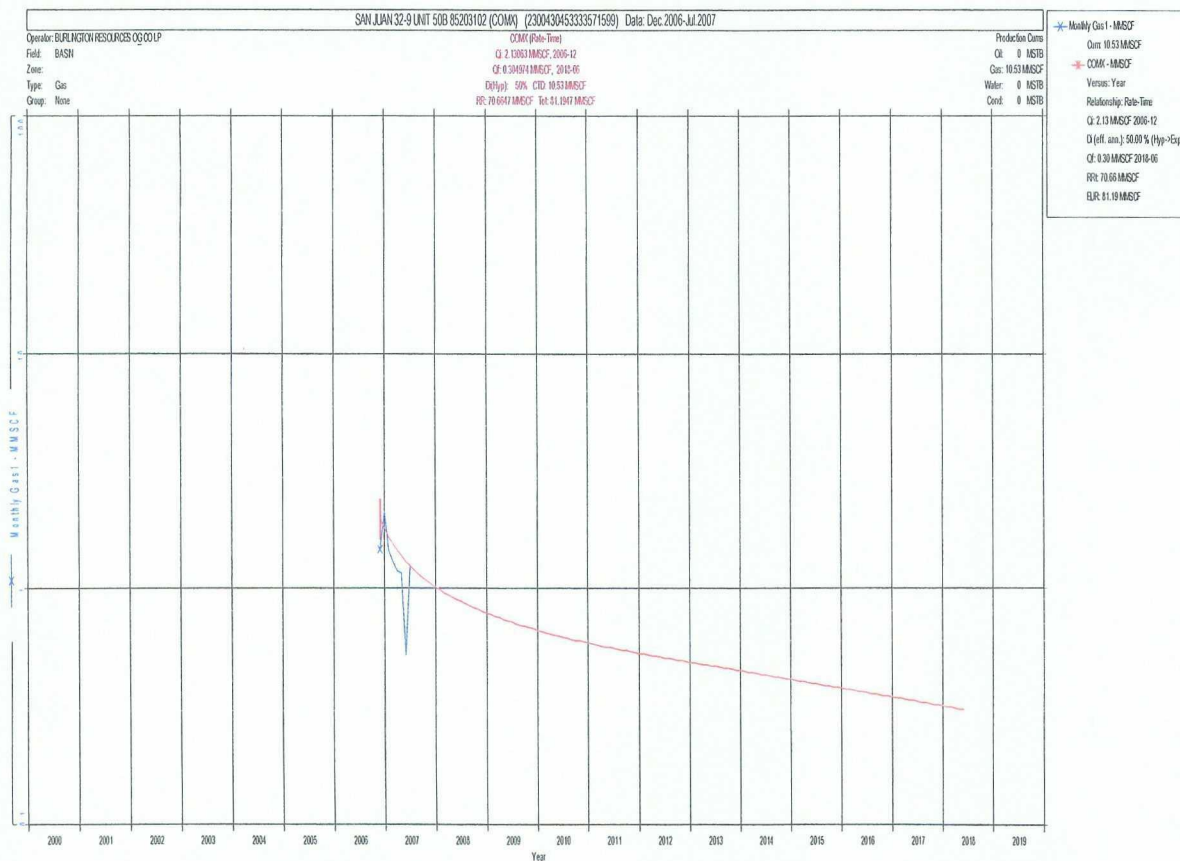
