The Oil Conservation Division (OCD) seeks an order finding that Chaparral Energy, LLC, knowingly and willfully violated OCD Rule 19.15.13.1105 NMAC by not filing a C-105 Well Completion Report Form for the Roberts 13 No. 001Y well (API No. 30-015-34892)

Case 14006 Pre-hearing Statement Page 1 of 2 within the time limits required under the Rule; requiring Chaparral Energy, LLC, to file a C-105 Well Completion Report Form for said well by a date certain; and assessing penalties against Chaparral Energy, LLC, for its knowing and willful violation of OCD Rule 19.15.13.1105.

According to OCD records, the Roberts 13 No. 001Y well was completed in May 2006. OCD Rule 19.15.13.1105 requires a C-105 Well Completion Report Form to be filed within 20 days following the completion or re-completion of any well. Chaparral Energy, LLC, has not filed a C-105 Well Completion Report Form for said well, and did not respond to OCD's July 12, 2007 letter of violation or August 8, 2007 notice of violation.
