

LIMITED JOINDER OF THE VALUE BCV STATE COM #1 OPERATING AGREEMENT

Whereas, Yates Petroleum Corporation as operator and Yates Drilling Company, Myco Industries, Inc., Abo Petroleum Corporation, Campbell Investment Company, Calto Oil Company, Dansk Pipeline, L.P., Gruy LLC, Thomton Operating Corporation, Marley Livestock, Inc., Robert C. Marley Estate and Lauralea Marley as non-operators have executed a certain operating agreement dated February 19, 2004 which covers the following described lands in Chaves County, New Mexico (hereinafter OA):

Township 8 South, Range 26 East, NMPM Section 2: Lots 1, 2 (N/2NE/4), SE/4NE/4, SE/4, SW/4NE/4 a/k/a E/2.

Whereas, John D. Cadigan, the Estate of Linda Cadigan and Greg Vujovich have not executed the above captioned OA.

Whereas, the parties to the OA plan to drill the Value BCV State Com #2 (Value #2) in the E/2 of Section 2, Township 8 South, Range 26 East, N.M.P.M. at a footage location of 660' FNL & 1980' FEL.

Whereas, the undersigned desire to execute this ratification for the limited purpose of drilling and producing the Value #2.
