ConocoPhillips, by its attorneys, Kellahin & Kellahin, seeks an order for an exception to the well density requirements of the Basin-Dakota Gas Pool, Rio Arriba County, New Mexico. Applicant seeks an exception to the well density requirements of Rule I.B of the Special Rules and Regulations for the Basin-Dakota Gas Pool to permit it to produce the following 2 Dakota gas wells in the same quarter-quarter section (NW/4SW/4) on a standard spacing and proration unit comprised of the W/2 of Section 24, T28N, R7W, NM/PM:

In support of its application ConocoPhillips states:

- (1) ConocoPhillips is the current operator of the San Juan 28-7 Unit that includes, among other acreage, the W/2 of Section 24, T28N, R7W, Rio Arriba County, New Mexico.
- (2) Because this spacing unit ("GPU") is within the interior of this Federal Unit with all adjoining spacing units being in the Dakota participating area, all interest owners are common among the subject GPU and all adjoining GPUs.

This spacing Unit ("GPU") currently contains four wells completed in the Basin-Dakota Gas Pool as follows:

- (a) the San Juan 28-7 Unit Well No. 259 (API #30-039-21690) located 1450 feet FSL and 790 feet FWL (Unit L) of this section; and
- (b) the San Juan 28-7 Unit Well No. 259G (API #30-039-27290) located 2370 feet FSL and 225 feet FWL (Unit L) of this section
- (c) the San Juan 28-7 Unit Well No. 259M (API #30-039-25558) located 790 feet FNL and 960 feet FWL (Unit D) of this section; and
- (b) the San Juan 28-7 Unit Well No. 259F (API #30-039-27044) located 1945 feet FNL and 2225 feet FWL (Unit F) of this section.

(3) The Basin-Dakota Gas Pool is governed by Special Rules and Regulations which provide for 320-acre spacing and proration units on which as many as four wells may be drilled. See As amended by Order R-10987-B, effective June 30, 2000 and Superseded by Order R-10981-B(!) effective January 29, 2002. These Special Pool Rules and Regulations provide, among other things, that an infill well shall not be located within the same quarter-quarter section (40-acre tract) as another well.

(4) On or about April, 2006, ConocoPhillips completed the Well No. 259G in the Dakota such that the No. 259 and the No. 259G are both in the same quarter-quarter section and are located at standard distances from the outer boundaries of this GPU.

(5) Upon becoming aware of its mistake, ConocoPhillips shut-in the Well No. 259 that remains shut-in and is not producing from the Dakota formation.

(6) While the total number of four wells in this Dakota gas proration unit ("GPU") is allowed, the Well No. 259 and Well No. 259G are

(6) While the total number of four wells in this Dakota gas proration unit ("GPU") is allowed, the Well No. 259 and Well No. 259G are located in the same quarter-quarter section and therefore are in violation of the density requirements of these Special Pool Rules.

(7) ConocoPhillips therefore requests that the Division enter its order granting an exception to the well density requirements of Rule I.B of the Special Rules and Regulations of the Basin-Dakota Gas Pool approving the location of the San Juan 28-7 Unit Well No. 259 and the Well No. 259G in the same quarter-quarter section and authorizing ConocoPhillips to simultaneously produce both wells.

(8) Approval of this application will not impair the correlative rights of any other interest owner in the Basin-Dakota Gas Pool and will afford ConocoPhillips the opportunity to utilize the existing wells to produce the reserves from this GPU.

(9) Approval of this application will be in the best interests of conservation, the prevention of waste and the protection of correlative rights.

WHEREFORE, ConocoPhillips requests that this application be set for hearing before an Examiner of the Oil Conservation Division on November 1, 2007 and after notice and hearing as required by law, the Division enter its order granting an exception to the well density requirements of Rule I.B of the Special Rules and Regulations of the Basin-Dakota Gas Pool approving the location of the San Juan 28-7 Unit Wells No. 259 and 259G in the Dakota formation and authorizing ConocoPhillips to simultaneously produce both wells.

Applicant seeks an exception to the well density requirements of Rule 1.B of the Special Rules and Regulations for the Blanco-Mesaverde Gas Pool to permit it to produce the following 2 Mesaverde gas wells in the same quarter-quarter section (NW/4NE/4) on a standard spacing and proration unit comprised of the E/2 of Section 34, T28N, R7W, NMPM:

In support of its application ConocoPhillips states:

- (1) ConocoPhillips is the current operator of the San Juan 28-7 Unit that includes, among other acreage, the E/2 of Section 34, T28N, R7W, Rio Arriba County, New Mexico.
- (2) Because this spacing unit ("GPU") is within the interior of this Federal Unit with all adjoining spacing units being in the Mesaverde participating area, all interest owners are common among the subject GPU and all adjoining GPUs.

(3) This spacing Unit ("GPU") currently contains four wells completed in the Blanco-Mesaverde Gas Pool as follows:

- (a) the San Juan 28-7 Unit Well No. 225F (API #30-039-66940) located 2170 feet FEL and 740 feet FNL (Unit B) of this section;
- (b) the San Juan 28-7 Unit Well No. 91 (API #30-039-07270) located 1460 feet FEL and 900 feet FNL (Unit B) of this section; and
- (c) the San Juan 28-7 Unit Well No. 225E (API #30-039-26173) located 1350 feet FSL and 2330 feet FEL (Unit J) of this section.
- (d) the San Juan 28-7 Unit Well No. 225M (API #30-039-25545) located 830 feet FSL and 930 feet FEL (Unit P) of this section.

(4) The Blanco-Mesaverde Gas Pool is governed by Special Rules and Regulations which provide for 320-acre spacing and proration units on which as many as four wells may be drilled. See Order R-8170, as superseded by Order R-10987-A, effective February 1, 1999 and amended by Order R-10987-A (1), effective December 2, 2002. These Special Pool Rules and Regulations provide, among other things, that an infill well shall not be located within the same quarter-quarter section (40-acre tract) as another well.

(5) On or about January 8, 2002, ConocoPhillips recompleted the Well No. 225F from the Dakota to the Mesaverde such that the No. 225F and the No. 91 are both in the same quarter-quarter section and are located at standard distances from the outer boundaries of this GPU.

(6) Upon becoming aware of its mistake, ConocoPhillips shut-in the Well No. 91 that remains shut-in and is not producing from the Mesaverde formation.

(7) While the total number of four wells in this Mesaverde gas proration unit ("GPU") is allowed, the Well No. 225F and Well No. 91 are located in the same quarter-quarter section and therefore are in violation of the density requirements of these Special Pool Rules.

(8) ConocoPhillips therefore requests that the Division enter its order granting an exception to the well density requirements of Rule I.B of the Special Rules and Regulations of the Blanco-Mesaverde Gas Pool approving the location of the San Juan 28-7 Unit Well No. 225F and the Well No. 91 in the same quarter-quarter section and authorizing ConocoPhillips to simultaneously produce both wells.

(9) Approval of this application will not impair the correlative rights of any other interest owner in the Blanco-Mesaverde Gas Pool and will afford ConocoPhillips the opportunity to utilize the existing wells to produce the reserves from this GPU.

(10) Approval of this application will be in the best interests of conservation, the prevention of waste and the protection of correlative rights.

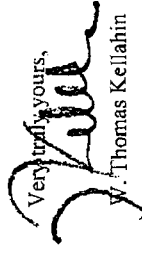

In support of its application ConocoPhillips states:

- (1) ConocoPhillips is the current operator of the San Juan 29-5 Unit that includes, among other acreage, the E/2 of Section 34, T29N, R5W, Rio Arriba County, New Mexico.

(2) This spacing Unit ("GPU") currently contains three wells completed in the Blanco-Mesaverde Gas Pool as follows:

- (a) the San Juan 29-5 Unit Well No. 34 (API #30-039-075150) located 1425 feet FNL and 2080 feet FEL (Unit G) of this section;
- (b) the San Juan 29-5 Unit Well No. 34R (API #30-039-21788) located 2450 feet FNL and 1850 feet FEL (Unit G) of this section; and
- (c) the San Juan 29-5 Unit Well No. 34M (API #30-039-30162) located (BHL) 1056 feet FSL and 2303 feet FEL (Unit O) of this section.

(3) The Blanco-Mesaverde Gas Pool is governed by Special Rules and Regulations which provide for 320-acre spacing and proration units on which as many as four wells may be drilled. See Order R-8170, as superseded by Order R-10987-A, effective February 1, 1999 and amended by Order R-10987-A (1), effective December 2, 2002. These Special Pool Rules and Regulations provide, among other things, that an infill well shall not be located within the same quarter-quarter section (40-acre tract) as another well.

(4) On or about January 4, 1996, ConocoPhillips' predecessor, Phillips Petroleum Company recompleted the Well No. 34R from the Dakota to the Mesaverde such that the No. 34R and the No. 34 are both in the same quarter-quarter section and are located at standard distances from the outer boundaries of this GPU.

(5) The Well 34R apparently was intended as a replacement well for the Well 34, but was produced and not plugged.

(6) Upon becoming aware of its mistake, ConocoPhillips shut-in the Well No. 34 that remains shut-in and is not producing from the Mesaverde formation.

(7) While the total number of wells in this Mesaverde gas proration unit ("GPU") is less than what is allowed, the Well No. 34 and Well No. 34R are located in the same quarter-quarter section and therefore are in violation of the density requirements of these Special Pool Rules.

(8) ConocoPhillips therefore requests that the Division enter its order granting an exception to the well density requirements of Rule I.B of the Special Rules and Regulations of the Blanco-Mesaverde Gas Pool approving the location of the San Juan 29-5 Unit Well No. 34 and the Well No. 34R in the same quarter-quarter section and authorizing ConocoPhillips to simultaneously produce both wells.

(9) Approval of this application will not impair the correlative rights of any other interest owner in the Blanco-Mesaverde Gas Pool and will afford ConocoPhillips the opportunity to utilize the existing wells to produce the reserves from this GPU.

(10) Approval of this application will be in the best interests of conservation, the prevention of waste and the protection of correlative rights.

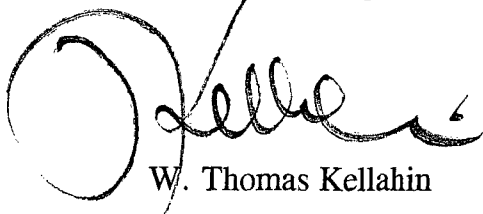

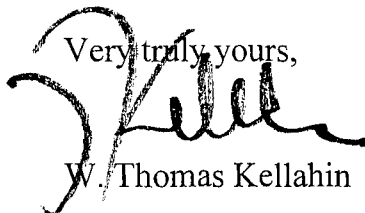
