1 EXAMINER JONES: Let's go ahead and call the first
2 case today. It will be Case 14105, Application of Trilogy
3 Operating, Incorporated for Compulsory Pooling in Lea County,
4 New Mexico.

5 Call for appearances.

6 MR. BRUCE: Mr Examiner, Jim Bruce of Santa Fe,
7 representing the applicants. I'm submitting this case by
8 affidavit.

9 EXAMINER JONES: Any other appearances?

10 MR. BRUCE: Mr. Examiner, I'm submitting this pooling
11 case by affidavit. Submitted as Exhibit 1 is an affidavit of
12 the landman. Trilogy Operating Inc., seeks to re-enter an
13 existing well, the Topaz Well No. 1, located 400 feet from the
14 north line and 2,050 feet from the west line of Section 25 of
15 19 South 28 East. That well was originally drilled, I believe,
16 to the Abo about five years ago. It is currently TA'd, I
17 think, and they are seeking to re-enter it to test the
18 Yates-Seven Rivers formation.

19 There are two interest owners being pooled, one of
20 whom is a former partner of mine, by the way, Anderson Carter,
21 and his cousin, Stuart Carter. They've been negotiating with
22 them to get a lease, and they are still negotiating with them,
23 but at this point they haven't received the lease.

24 Submitted as Exhibit C is the AFE for the re-entry,
25 and the overhead rates being sought are 4500 a month for a

1 drilling well and 500 a month for a producing well.

2 Exhibit 2 is the Affidavit of Notice to both of the
3 parties. They are both locatable, and they both did receive
4 notice of the hearing. So I submit Exhibits 1 and 2.

5 EXAMINER JONES: There's no unlocated parties?

6 MR. BRUCE: No unlocated parties.

7 EXAMINER JONES: Okay. Exhibits 1 and 2 will be
8 admitted into evidence. This Yates-Seven Rivers, is that oil
9 for sure?

10 MR. BRUCE: It is oil.

11 EXAMINER JONES: It's not gas?

12 MR. BRUCE: Yeah, I -- yeah. The South ^{Nadine}~~Canadian~~
13 Yates-Seven Rivers pool, and it is an oil pool under the
14 Division's records.

15 EXAMINER JONES: Okay. Terry, do you have any
16 questions?

17 MR. WARNELL: No, I don't think so.

18 EXAMINER JONES: Do you have any questions?

19 MR. BROOKS: You've got your requested overhead in
20 here somewhere?

21 MR. BRUCE: Yeah. Page 2 of the affidavit,
22 Paragraph 2.

23 MR. BROOKS: Okay. I see it, 4500 and 500.

24 MR. BRUCE: 2(g).

25 MR. BROOKS: Okay. I guess that's okay. I can't

1 think of anything else.

2 EXAMINER JONES: Okay. With that, we'll take Case
3 14105 under advisement.


