1           WHEREUPON, the following proceedings were had at  
2   8:20 a.m.:

3           EXAMINER EZEANYIM: Good morning, everybody.  
4   This hearing will come to order. Today is September 6th,  
5   at approximately 8:15 a.m. in the morning.

6           Before I go into the docket, I would like to make  
7   a couple of announcements.

8           The October hearing, which is on October 4, has  
9   been moved up to October 3 because of arrangement with the  
10   hearing room. So we're going to put it in the docket, the  
11   October 4 docket, to alert people that the hearing has been  
12   moved from October 4 to October 3, Wednesday, so that you  
13   can make your travel arrangements. So I wish you would  
14   spread the word so that -- because we want to move it.  
15   This room will not be available on the 4th and the 5th, and  
16   I don't want to do it piecemeal, do some part on Thursday  
17   and do some part on Friday. So the best thing is to move  
18   it on Wednesday, October 3. So you're going to see it in  
19   the docket, it's already on the docket for October 4th,  
20   that the hearing will be October 3rd.

21           As you all know, most of you must have known, we  
22   lost an Examiner to retirement, so we're looking for


