STATEMENT OF CASE

APPLICANT

Applicant in the above-styled cause seeks an order approving salt water disposal into the Wolfcamp and Cisco formations in the Geronimo 27 State Com Well No. 2, located 990 feet from the south line and 660 feet from the West line of Section 27, Township 17 South, Range 28

East, NMPM. The well is located approximately 12-1/2 miles east-northeast of Atoka, New Mexico.

OPPONENT

Opponent asserts that the granting of this application will cause the undue waste of oil and gas by damaging productive formations under and around this tract. Disposal of produced water into the proposed well would also impact Opponent's correlative rights. Marbob therefore respectfully requests the Division deny this application.


