



APPLICATION

Applicant states:

1. That Applicant is an owner within the meaning of Section 70-2-17 (C), N.M.S.A., 1978 Compilation, and as such seeks to force-pool all of the oil and gas mineral interests in and to the following described lands situated in San Juan County, New Mexico:

Township 31 North, Range 11 West, N.M.P.M.

- a. ✓ SW/4 of Section 27, containing 160 acres, more or less, to be dedicated to a Pictured Cliffs formation well.
- b. NW/4 of Section 27, containing 160 acres, more or less, to be dedicated to a Pictured Cliffs formation well.
- c. The W/2 of Section 27 containing 320 acres, more or less, to be dedicated to a Mesaverde formation well.

2. That Applicant proposes to drill the above mentioned wells at standard locations on said lands to depths sufficient to test the applicable formations.

3. That Applicant desires to be designated the operator of the above described wells.

4. That the following royalty owners under a fee oil and gas lease have not consented to the pooling of their oil and gas interests in and to the well dedications as described above:

5. That to avoid the drilling of unnecessary wells, to protect correlative rights and to afford to the owner of each interest in the proposed proration unit the opportunity to recover or receive without unnecessary expense, its just and fair share of the hydrocarbons in each of the above described spacing or proration units, said lands as described above should be pooled as proposed herein.

WHEREFORE, Applicant respectfully requests:

1. That this application be set for hearing before an examiner of the division at the next available hearing date, and that notice of said hearing be given as required by law.
2. That upon hearing, the division enter its order pooling all oil and gas interests in the proration units as described above.
3. For such other relief as the division may deem appropriate under the circumstances.
