

CASE 1421.9 Application of Chesapeake Energy Corporation for cancellation of certain permits to drill ("APDs") issued to COG Operating LLC, Chaves County, New Mexico. Applicant seeks an order cancelling the Division's approval of the following three applications for permits to drill ("APD") issued to COG Oil & Gas LLC ("COG"):

(a) API 30-005-27978 for the Orion Federal #1H Well, a horizontal wellbore with a surface location in Unit H of Section 13, T15S, R31E, Chaves County and to be dedicated to a non-standard 160-acre spacing unit consisting of the S/2N/2 of this section.

(b) API 30-005-27994 for the Orion Federal #2H Well, a horizontal wellbore with a surface location in Unit I of Section 13, T15S, R31E, Chaves County and to be dedicated to a non-standard 160-acre spacing unit consisting of the N/2S/2 of this section.

(c) API 30-005-28001 for the Orion Federal #3H Well, a horizontal wellbore with a surface location in Unit P of Section 13, T15S, R31E, Chaves County and to be dedicated to a non-standard 160-acre spacing unit consisting of the S/2S/2 of this section.

These units are located approximately 1-1/2 miles west of the intersection of New Mexico state road FAS-1231 and FAS-1242, and approximately 32 miles east of Hagerman, New Mexico.

**APPLICATION**

Comes now CHESAPEAKE ENERGY CORPORATION ("Chesapeake") by its attorneys, Kellahin & Kellahin, applies to the New Mexico Oil Conservation Division ("Division") for an order cancelling the Division's approval of the following three applications for permits to drill ("APD") issued to COG Operating LLC ("COG"):

(a) API 30-005-27978 for the Orion Federal #1H Well, a horizontal wellbore with a surface location in Unit H of Section 13, T15S, R31E, Chaves County and to be dedicated to a non-standard 160-acre spacing unit consisting of the S/2N/2 of this section.

(b) API 30-005-27994 for the Orion Federal #2H Well, a horizontal wellbore with a surface location in Unit I of Section 13, T15S, R31E, Chaves County and to be dedicated to a non-standard 160-acre spacing unit consisting of the N/2S/2 of this section.

(c) API 30-005-28001 for the Orion Federal #3H Well, a horizontal wellbore with a surface location in Unit P of Section 13, T15S, R31E, Chaves County and to be dedicated to a non-standard 160-acre spacing unit consisting of the S/2S/2 of this section.

In support of its application, Chesapeake Energy Corporation ("Chesapeake") states:

1. Chesapeake has 50% of the working interest including the right to drill and develop the oil and gas minerals from the surface to the base of the Wolfcamp formation underlying the SE/4; S/2NE/4; NE/4NE/4; and NW/4SW/4 of Section 13, T15S, R31E, NMPM, Chaves County, New Mexico. See locator map attached as Exhibit "A"

2. COG's three proposed 160-acre non-standard oil spacing unit each contain four 40-acre tracts consisting of:

(a) N/2S/2:

Unit I and Unit J and Unit K Chesapeake = 50% and COG Oil & Gas LP=50%  
Unit L Penroc= 100%

(b) S/2S/2:

Unit O and Unit P Chesapeake = 50% and COG Oil & Gas LP=50%  
Unit M and Unit N Penroc = 100%

(c) S/2N/2:

Unit G and Unit H Chesapeake = 50% and COG Oil & Gas LP=50%  
Unit E and Unit F Penroc = 100%

3. The Division revised and modified its Form C-102 on October 12, 2005 to require that the Operator certify that:

"I hereby certify that the information contained herein is true and complete to the best of my knowledge and belief, and that this organization either owns a working interest or unleased mineral interest in the land including the proposed bottom hole location or has a right to drill this well at this location pursuant to a contract with an owner of such a mineral or working interest, or to a voluntary pooling agreement or a compulsory pooling order heretofore entered by the division."

4. About September 12, 2007, COG Operating, LLC filed applications for permit to drill ("APD") with the Bureau of Land Management-Roswell that were approved on October 23, November 1 and December 7, 2007 for the:

(a) API 30-005-27978 for the Orion Federal Com #1H Well, a horizontal wellbore with a surface location in Unit H of Section 13, T15S, R31E, Chaves County and to be dedicated to a non-standard 160-acre spacing unit consisting of the S/2N/2 of this section. See first page of APD and Division form C-102 attached as Exhibit "B"

(d) API 30-005-27994 for the Orion Federal Com #2H Well, a horizontal wellbore with a surface location in Unit I of Section 13, T15S, R31E, Chaves County and to be dedicated to a non-standard 160-acre spacing unit consisting of the N2S/2 of this section. See first page of APD and Division form C-102 attached as Exhibit "C"

(c) API 30-005-28001 for the Orion Federal Com #3H Well, a horizontal wellbore with a surface location in Unit P of Section 13, T15S, R31E, Chaves County and to be dedicated to a non-standard 160-acre spacing unit consisting of the S/2S/2 of this section. See first page of APD and Division form C-102 attached as Exhibit "D"

5. Attached to each of these APDs was a Division Form C-102, dated August 30, August 31, September 17, 2007, that was improperly certified because COG Operating LLC had placed the bottom hole location on Penroc's lease or proposed to penetrate a tract in which COG Oil & Gas LP had no interest and had not reach a voluntary agreement with Penroc or obtained a Division compulsory pooling order.

6. In doing so, COG violated the "operator certification" contained in Division Form C-102 by falsely certifying that it had an interest in each of the tracts to be penetrated by these three wellbores.

7. Chesapeake was the first operator to propose to COG on November 21, 2007 and to Penroc on December 7, 2007 that:

- (a) the N/2S/2 of this section be to dedicated as a 160-acre Wolfcamp oil spacing unit for production from the Wolfcamp formation to be obtained from its proposed horizontal wellbore the Wrinkle 13 Federal Com Well No. 1H to be located drilled as a horizontal wellbore as shown on Form C-102 attached as Exhibit "E".
- (b) the S/2S/2 of this section be to dedicated as a 160-acre Wolfcamp oil spacing unit for production from the Wolfcamp formation to be obtained from its proposed horizontal wellbore the Wrinkle 13 Federal Com Well No. 2H to be located drilled as a horizontal wellbore as shown on Form C-102 attached as Exhibit "F".
- (c) the S/2N/2 of this section be to dedicated as a 160-acre Wolfcamp oil spacing unit for production from the Wolfcamp formation to be obtained from its proposed horizontal wellbore the Wrinkle 13 Federal Com Well No. 3H to be located drilled as a horizontal wellbore as shown on Form C-102 attached as Exhibit "G".

8. Notice of this application and hearing has been send to the parties set forth on Exhibit "H"

WHEREFORE, Chesapeake, as applicant, requests that this application be set for hearing on October 30, 2008 before the Division's duly appointed examiner, and that after notice and hearing as required by law, the Division enter its order cancelling these APDs.




**BOTTOM HOLE LOCATION**




