***Application of the New Mexico Oil Conservation Division for a Compliance Order against General Operating Company, Gene A. Snow and/or Snow Oil & Gas, Inc.*** The Applicant seeks an order determining the operator or operators of the Kleeman #001, 30-015-00250, Section 27, Township 18S, Range 26E; finding the operator(s) in violation of 19.15.4.201 NMAC as to said well; requiring operator(s) to bring the well into compliance with 19.15.4.201 NMAC by a date certain and authorizing the division to plug the well and forfeit the applicable financial assurance in the event of non-compliance. The well is located approximately 10 miles southeast of Artesia in Eddy County, New Mexico.
  
2. **CASE 14189:** ***Application of the New Mexico Oil Conservation Division for a Compliance Order against Americo Energy Resources, LLC.*** Applicant seeks an Order requiring Operator to comply with Rule 19.15.3.101 and Rule 19.15.4.201 by a date certain, and in event of Operator's non-compliance, authorizing the Division to plug the wells and forfeit the financial assurance.
