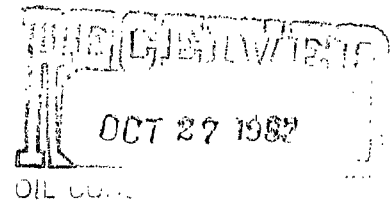

APPLICATION

COMES NOW, GETTY OIL COMPANY, by its undersigned attorneys,  
and hereby makes application to the Oil Conservation Division for  
downhole commingling and in support thereof, respectfully states:

1. Applicant is the operator of the C. W. Roberts 3A Well located 1650 feet from the South line and 810 feet from the West line and the C. W. Roberts 6A Well located 1660, feet from the North line and 820 feet from the West line of Section 18, Township 25 North, Range 3 West, N.M.P.M., Rio Arriba County, New Mexico.
2. Applicant proposes to commingle in the well bore of said wells oil production from the Ojito Gallup-Dakota Pool and gas production from the Blanco Mesaverde pool.
3. Approval of this application will result in the production of hydrocarbons that would not otherwise be produced, will prevent waste and will not cause damage to either the Gallup-Dakota or Mesaverde formations.
4. Approval of this application will not impair the correlative rights of any offset operators.


WHEREFORE, GETTY OIL COMPANY requests that this application be set for hearing before a duly appointed examiner of the Oil Conservation Division on November 10, 1982, that notice be given as

required by law and the rules of the Division and that the Division enter its order granting the applicant permission to downhole commingle oil production from the Gallup-Dakota and gas production from the Mesaverde formation in the well bores of its C. W. Roberts 3A and 6A Wells.
