By the Division Order No.R-12985 issued in Case No. 14152 on September 3, 2008, Read & Stevens, Inc, was granted authority to commence the drilling of the Highway 5 Federal Com Well No. 1, on or before November 30, 2008.

By letter dated November 17, 2008, the Division mistakenly extended the commencement of drilling this well to March 31, 2008 instead of March 31, 2009. 
