Ladies and Gentlemen:

Devon Energy Production Company, L. P. ("Devon") is proposing to drill and complete the Acme 15 Fed Com 1 well, a 12,725' Lower Morrow well to be located in the E/2 of Section 15-T19S-R31E, Eddy County, New Mexico (320 acre spacing). A recent review of title indicates that the owners on the attached list own rights as to the Strawn formation only in the NE/4 SE/4 of Section 15-T19S-R31E, Eddy County, New Mexico. The Strawn formation is spaced on 160 acres in this township.

Devon is proposing that Joint Operating Agreement ("JOA") dated October 15, 2008 between Devon Energy Production Company, L. P., as Operator and Marbob Energy Corporation, et al, as Non-Operators covering the drilling of the referenced well govern the Strawn Formation in the SE/4 of Section 15. Note that there are two contract areas on Exhibit "A" to the JOA. Contract Area "A" covers all formations less and except the Strawn formation (320 acres in the E/2) and Contract Area "B" covers the Strawn formation only (160 acres in the SE/4).

Devon has also included under Article XV, Other Provisions of the JOA, a cost allocation formula which sets forth how the cost shall be borne by the various participating owners, according to their respective interest in the units involved.
