1. ***CASE 14247: Application of XTO Energy Inc. for simultaneous dedication and an exception to the well density/location requirements of the Basin-Fruitland Coal Gas Pool, San Juan County, New Mexico.*** Applicant seeks simultaneous dedication and an exception to the well density requirements within the Low Productivity Area governed by Rule 7(d)(1)(i) of the Special Rules and Regulations for the Basin-Fruitland Coal Gas Pool to permit it to produce the following 2 Fruitland coal gas wells in the same quarter section (NW/4) on a standard 314.70-acre spacing and proration unit comprised of the W/2 of Section 6, T27N, R11W, NMPM:

- (a) Mudge A No. 8R well (API # 30-045-30519) (Unit Letter D) and
- (b) Mudge A No 12 well (API # 30-045-28830 (Unit Letter E)

These wells are located approximately 12 miles southeast of the Farmington, New Mexico.
