(A) Create a new pool in Chaves County, New Mexico classified as a gas pool and designated as the Bosque; Pennsylvanian, North Gas Pool (**Pool Code 97298**). The discovery well, the Bobwhite 'BBH' Deep Federal Com. #1 (**API No. 30-005-62135**) completed by Yates Petroleum Corporation, is located in Unit M of Section 3, Township 6 South, Range 26 East, NMPM.
