DENNIS LANGLITZ'S PREHEARING STATEMENT

Pursuant to 19.15.14.1211(B) NMAC, applicant Dennis Langlitz ("Langlitz") submits his Prehearing Statement.

I. Parties

Langlitz, who is the applicant, is represented by the undersigned counsel. The Oil Conservation Division ("the Division"), through attorney Gail MacQuesten, has entered an appearance in this case.

II. Concise Statement of the Case

Langlitz seeks authorization to inject into his Saladar Unit No. 2, No. 4, No. 6, No. 7, No. 8, and No. 12 wells, which are part of the previously approved Saladar Unit Waterflood Project and are located in Section 33, Township 20 South, Range 28 East in Eddy County. The Division has filed a Prehearing Statement which states that it takes no position on the merits of Langlitz's application, and that the Division has entered its appearance to bring to the attention of the Hearing Examiner the compliance issues identified in the Prehearing Statement.

III. Langlitz's Witnesses

Langlitz and petroleum engineer William (Mike) Kincaid of Stephens Engineering in Wichita Falls, Texas will testify in support of the application.

IV. Langlitz's Case Presentation

Langlitz anticipates that it will take thirty (30) minutes to present his case.

V. Unresolved Procedural Matters

Langlitz is not aware of any procedural matters that would require resolution prior to the hearing.


