Docket Nos. 21-09 and 22-09 are tentatively set for June 11, 2009 and June 25, 2009. Applications for hearing must be filed at least 30 days in advance of hearing date. OCD Rule 1211.B requires parties who intend to present evidence at an adjudicatory hearing to file a pre-hearing statement no later than the Thursday before the hearing, and serve a copy on opposing counsel of record. If the OCD does not receive a pre-hearing statement from the applicant by the close of business on the Thursday before the hearing, the hearing may be continued or dismissed by order of the examiner. If a protesting party fails to submit a timely pre-hearing statement, the hearing may be continued at the applicant's request. The following cases will be heard by an Examiner.

1. **CASE 14302:** *(Continued from the May 28, 2009 Examiner Hearing.) (This case will be dismissed.) Application of the New Mexico Oil Conservation Division for a Compliance Order against Slayton Resources, Inc.* The Applicant seeks an order finding Operator in violation of Rule 19.15.25.8 NMAC as to one well; requiring Operator to bring the well into compliance by a date certain; requiring Operator to plug the well if it is not brought into compliance by set date; authorizing the division to plug and abandon the well and forfeit the applicable financial assurance in event of Operator's non-compliance; and assessing penalties.
