They simply have refused to respond to any 3 owners. offers to lease or to well proposals. I think these same 4 5 entities have been force pooled in four or five other wells in this section, and they simply haven't responded. 6 MR. BROOKS: Now, you said three. 7 Elizabeth F. Ferguson Blanek and Elizabeth F. Ferguson, 8 9 care of Stringer Oil and Gas, I presume, are the same 10 person? 11 MR. BRUCE: Yeah. I'm not quite sure. According to my wife, who knows her, it is, but I think 12 it shows up differently in the county records. 13 14 MR. BROOKS: Okay. 15 MR. BRUCE: There's a land plat attached, 16 the proposal letter that was sent out about two and a half months ago to these people. And, like I said, they 17 have simply never responded.
