



APPLICATION

STRATA PRODUCTION COMPANY ("Strata"), through its undersigned attorneys, hereby makes application pursuant to the provisions of N.M.Stat.Ann. §70-2-17, (1978), for an order pooling all mineral interests in all formations developed on 320-acre spacing in the W/2 of Section 22, Township 22 South, Range 32 East, N.M.P.M., Lea County, New Mexico, and in support thereof states:

- 1. Strata is a working interest owner in the W/2 of Section 22 and has the right to drill thereon.
- 2. Strata proposes to dedicate the above-described spacing or proration unit to its Hill Federal No. 1 Well to be drilled at a standard location 1980 feet from the west line and 1980 feet from the south line of Section 22, to a depth sufficient to test any and all formations down to the base of the Morrow Formation.
- 3. Strata has sought and has been unable to obtain either voluntary agreement for pooling or farmout from certain interest owners in the spacing unit identified at <u>Exhibit A</u> to this Application.
- 4. The pooling of interest will avoid the drilling of unnecessary wells, will prevent waste and will protect correlative rights.

5. In order to permit Strata to obtain its just and fair share of the oil and gas underlying the subject lands, all mineral interests should be pooled, and Strata should be designated the operator of the well to be drilled.

WHEREFORE, Strata prays that this Application be set for hearing before an Examiner of the Oil Conservation Division on July 23, 1998, and, after notice and hearing as required by law, the Division enter its order pooling the lands, including provisions for Strata to recover its costs of drilling, equipping and completing the well, its costs of supervision while drilling and after completion, and its overhead charges, provisions imposing a risk factor for the risk assumed by Strata in drilling, completing and equipping the well, provisions for a Joint Operating Agreement for future operations, and such other provisions as the Division deems appropriate.
