WHEREUPON, the following proceedings were had at 1 2 8:21 a.m.: 3 EXAMINER STOGNER: I'll call Case 12,011. MR. CARROLL: Application of Strata Production 4 Company for compulsory pooling, Lea County, New Mexico. 5 6 EXAMINER STOGNER: Call for appearances. 7 MR. CARR: May it please the Examiner, my name is 8 William F. Carr with the Santa Fe law firm Campbell, Carr, 9 Berge and Sheridan. We represent Strata Production Company in this 10 case, and I have a statement. 11 MR. BRUCE: Mr. Examiner, Jim Bruce of Santa Fe, 12 representing Exxon Corporation and Robert E. Landreth. 13 14 I have no witnesses. 15 EXAMINER STOGNER: Okay. Mr. Carr? May it please the Examiner, two weeks 16 MR. CARR: 17 ago this matter came on for hearing before Examiner Catanach, and at the conclusion of the hearing the case was 18 19 continued for two weeks to permit the parties to take 20 advantage of this additional time to attempt to reach a 21 voluntary agreement for the development of the subject 22 acreage. 23 Since that time, the parties have been in communication on at least six different occasions, the 24 25 parties being Strata and Exxon. They were unable to reach

a voluntary agreement.

We have subsequent to that time been advised that on -- in late July, I believe July 31st, this interest was assigned by Exxon, the Exxon interest, to Robert E. Landreth.

And so at this point in time I can report that we attempted to reach voluntary agreement, we did not, and we would request that case be taken under advisement.

I also have an affidavit that was prepared by Jo
McInerney, who is the contract landperson for Strata
Petroleum Company. She testified at the hearing, and
basically it is a summary of the contacts between Exxon and
Strata, and attached to it are the Exxon and Strata
correspondence, the last document being a copy of the
assignment from Exxon to Mr. Landreth.

I would like to -- I would request that that be included in the record of this case.

MR. BRUCE: I have no objection.

EXAMINER STOGNER: Mr. Bruce, do you have any statement at this time?

MR. BRUCE: Just briefly, Mr. Examiner. The parties did negotiate, they couldn't come to terms. Exxon did come to terms with Mr. Landreth who, of course, as Exxon's successor, is subject to this pooling application.

EXAMINER STOGNER: Is there anything further in
