6. **Division Rule 19.15.8.9 NMAC** requires that Operators post additional financial assurances/one-well financial assurances for wells that have been inactive/in temporary abandonment for more than two years, with the amounts of such single-well financial assurances being based upon the total depth of the well involved. Rule 19.15.8.9 NMAC went into full effect as of January 1, 2008. *Id.*

7. As of the date of filing of the Original Application in this matter, April 23, 2009, Nacogdoches Oil and Gas owed single-well financial assurances for 39 of its wells (total amount owed approximately **\$264,945** as of that date), identified as follows:

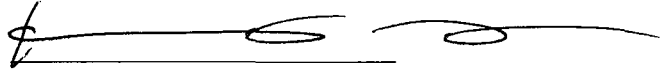

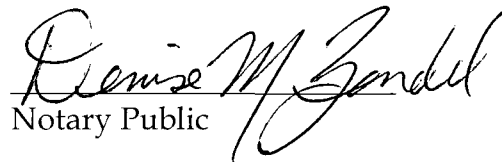
