STATEMENT OF THE CASE

APPLICANT

Applicant seeks a compliance order requiring NOG to bring 121 wells, located in McKinley County, into compliance.

OPPONENT

NOG has been working to bring its wells into compliance. A number of the wells listed in the case are already in compliance. As to other wells, NOG is constrained by current limits on its water disposal capabilities, which limits the number of wells which it can produce. As a result,

NOG has prepared and will be filing a water disposal application to increase its disposal capability, which will allow it to bring other wells into compliance.


