

On October 9, 2007 the San Juan 29-7 Unit Seventeenth Expansion for the Dakota formation was submitted to our office for approval. The approval for this expansion was accomplished on October 12, 2007. The submission of this expansion caused the following Communitization Agreement (CA) to become obsolete due to the inclusion into the Dakota participating area.

NMNM-116306, Sec. 4, T29N, R7W, W $\frac{1}{2}$ dedication for the San Juan 29-7 Unit #34B, Effective 7/01/2006

This agreement communitized particular acres of Federal lands within the San Juan 29-7 Unit as to natural gas and associated liquid hydrocarbons producible from the Dakota formation. The term of the agreement was for 2 years and for so long thereafter as communitized substances are produced in paying quantities.

Our records indicate that the well dedicated to the described agreements were completed and that the public interest requirements for the communitization agreement, pursuant to 43 CFR 3105.2-3, have been met.

The effective termination date of this CA is July 1, 2006, this date being the effective date of the Seventeenth Expansion to the Dakota formation. All subject Federal leases involved with this CA are held by the Unit. All indicated well will report to 891001650A (Dakota participating area for the San Juan 29-7 Unit) from effective termination date of the CA.
