- 3. The Applicant, Yates Petroleum Corporation, is designated as Unit Operator in said Unit Agreement and all oil and gas in the all formations are unitized.

- 4. The proposed Unit Area covers all, or substantially all, of the geological structures or anomaly involved.
- 5. Said Unit Agreement and the unitized operation and management of the Unit Area will be in the interest of conservation, the prevention of waste and the protection of correlative rights.
