#### Ladies and Gentlemen:

This letter is to advise you that Chesapeake Operating, Inc. has filed the enclosed application with the New Mexico Oil Conservation Division seeking an order statutorily unitizing for the purpose of establishing a secondary recovery project, and at a later date a tertiary recovery project in the Strawn formation. The vertical limits of the unitized formation to be included within the proposed unit shall be the separate common source of supply of oil and gas underlying the Unit Area which is commonly known as the Strawn formation, the vertical limits of which extend from the top of the lower Strawn formation 11298 feet to the top of the Lower Strawn "B" formation 11522 feet (-7494 feet to -7718 feet subsea) as measured by the Compensated Density/Compensated Neutron Log run in 1985 on the Amerind Oil Company, Carter #2 Well (API No. 30-025-29248), located 1330' from the North Line and 1980' from the East line of Section 28, Township 16 South, Range 37 East, NMPM, Lea County, New Mexico.

This statement must include: the names of the parties and their attorneys; a concise statement of the case; the names of all witnesses the party will call to testify at the hearing; the approximate time the party will need to present its case; and identification of any procedural matters that are to be resolved prior to the hearing.
