OCD Rule 1211.B requires parties who intend to present evidence at an adjudicatory hearing to file a pre-hearing statement no later than the Thursday before the hearing, and serve a copy on opposing counsel of record. If the OCD does not receive a pre-hearing statement from the applicant by the close of business on the Thursday before the hearing, the hearing may be continued or dismissed by order of the examiner. If a protesting party fails to submit a timely pre-hearing statement, the hearing may be continued at the applicant's request. The following cases will be heard by an Examiner.

1. **CASE 14387:** (Continued from the October 29, 2009 Examiner Hearing.)  
*Application of the New Mexico Oil Conservation Division for a Compliance Order against Dennis Langlitz.* The Applicant seeks an order revoking Operator's authority to inject into his wells and pursuant to NMSA 1978, Section 70-2-14(B), an order requiring Operator to plug and abandon all the wells he operates in New Mexico and authorizing Applicant to plug and abandon the wells and forfeit the applicable financial assurance in the event of non-compliance.
