

OPERATING AGREEMENT

THIS AGREEMENT, entered into by and between YATES PETROLEUM CORPORATION, a New Mexico corporation, 105 S. 4th Street, Artesia, NM 88210 , hereinafter designated and referred to as "Operator", and the signatory party or parties other than Operator, sometimes hereinafter referred to individually herein as "Non-Operator", and collectively as "Non-Operators",

WITNESSETH:

WHEREAS, the parties to this agreement are owners of oil and gas leases and/or oil and gas interests in the land identified in Exhibit "A", and the parties hereto have reached an agreement to explore and develop these leases and/or oil and gas interests for the production of oil and gas to the extent and as hereinafter provided:

NOW, THEREFORE, it is agreed as follows:

ARTICLE I. DEFINITIONS

20 As used in this agreement, the following words and terms shall have the meanings here ascribed to them:

A. The term "oil and gas" shall mean oil, gas, casinghead gas, gas condensate, and all other liquid 22 or gaseous hydrocarbons and other marketable substances produced therewith, unless an intent to 23 limit the inclusiveness of this term is specifically stated. 24

B. The terms "oil and gas lease", "lease" and "leasehold" shall mean the oil and gas leases cov- $\mathbf{25}$ ering tracts of land lying within the Contract Area which are owned by the parties to this agreement. 26 27 C. The term "oil and gas interests" shall mean unleased fee and mineral interests in tracts of land lying within the Contract Area which are owned by parties to this agreement. 28

D. The term "Contract Area" shall mean all of the lands, oil and gas leasehold interests and oil 29 and gas interests intended to be developed and operated for oil and gas purposes under this agreement. 30 Such lands, oil and gas leasehold interests and oil and gas interests are described in Exhibit "A". 31

E. The term "drilling unit" shall mean the area fixed for the drilling of one well by order or rule 32 of any state or federal body having authority. If a drilling unit is not fixed by any such rule or order, 33 a drilling unit shall be the drilling unit as established by the pattern of drilling in the Contract Area 34 or as fixed by express agreement of the Drilling Parties. 35

F. The term "drillsite" shall mean the oil and gas lease or interest on which a proposed well is to 36 37 be located.

38 G. The terms "Drilling Party" and "Consenting Party" shall mean a party who agrees to join in and pay its share of the cost of any operation conducted under the provisions of this agreement. 39

40 H. The terms "Non-Drilling Party" and "Non-Consenting Party" shall mean a party who elects 41 not to participate in a proposed operation.

Unless the context otherwise clearly indicates, words used in the singular include the plural, the plural includes the singular, and the neuter gender includes the masculine and the feminine.

ARTICLE III. INTERESTS OF PARTIES

A. Oil and Gas Interests:

If any party owns an unleased oil and gas interest in the Contract Area, that interest shall be treated for the purpose of this agreement and during the term hereof as if it were a leased interest under the form of oil and gas lease attached as Exhibit "B". As to such interest, the owner shall receive royalty on production as prescribed in the form of oil and gas lease attached hereto as Exhibit "B". Such party shall, however, be subject to all of the provisions of this agreement relating to lessees, to the extent that it owns the lessee interest.

13 B. Interest of Parties in Costs and Production:

Exhibit "A" lists all of the parties and their respective percentage or fractional interests under this 15 16 agreement. Unless changed by other provisions, all costs and liabilities incurred in operations under 17 this agreement shall be borne and paid, and all equipment and material acquired in operations on the Contract Area shall be owned by the parties as their interests are shown in Exhibit "A". All produc-18 tion of oil and gas from the Contract Area, subject to the payment of lessor's royalties which will be 19 borne by the Joint Account, shall also be owned by the parties in the same manner during the term 20 hereof; provided, however, this shall not be deemed an assignment or cross-assignment of interests cov-21 22 ered hereby.

ARTICLE IV. TITLES

27 A. Title Examination:

Title examination shall be made on the drillsite of any proposed well prior to commencement of 29 drilling operations or, if the Drilling Parties so request, title examination shall be made on the leases 30 and/or oil and gas interests included, or planned to be included, in the drilling unit around such well. 31 The opinion will include the ownership of the working interest, minerals, royalty, overriding royalty 32 and production payments under the applicable leases. At the time a well is proposed, each party con-33 34 tributing leases and/or oil and gas interests to the drillsite, or to be included in such drilling unit, shall 35 furnish to Operator all abstracts (including Federal Lease Status Reports), title opinions, title papers and curative material in its possession free of charge. All such information not in the possession of or 36 37 made available to Operator by the parties, but necessary for the examination of title, shall be obtained by Operator. Operator shall cause title to be examined by attorneys on its staff or by outside attorneys. 38 39 Copies of all title opinions shall be furnished to each party hereto. The cost incurred by Operator in 40 this title program shall be borne as follows:

42 <u>Option No. 1:</u> Costs incurred by Operator in procuring abstracts and title examination (including 43 preliminary, supplemental, shut-in gas royalty opinions and division order title opinions) shall be a 44 part of the administrative overhead as provided in Exhibit "C," and shall not be a direct charge, whether 45 performed by Operator's staff attorneys or by outside attorneys.

47 [X] Option No. 2: Costs incurred by Operator in procuring abstracts and fees paid outside attorneys 48 for title examination (including preliminary, supplemental, shut-in gas royalty opinions and division 49 order title opinions) shall be borne by the Drilling Parties in the proportion that the interest of each 50 Drilling Party bears to the total interest of all Drilling Parties as such interests appear in Exhibit "A". 51 Operator shall make no charge for services rendered by its staff attorneys or other personnel in the 52 performance of the above functions.

Each party shall be responsible for securing curative matter and pooling amendments or agreements required in connection with leases or oil and gas interests contributed by such party. The Operator shall be responsible for the preparation and recording of Pooling Designations or Declarations as well as the conduct of hearings before Governmental Agencies for the securing of spacing or pooling orders. This shall not prevent any party from appearing on its own behalf at any such hearing.

No well shall be drilled on the Contract Area until after (1) the title to the drillsite or drilling unit has been examined as above provided, and (2) the title has been approved by the examining attorney or title has been accepted by all of the parties who are to participate in the drilling of the well.

64 B. Loss of Title:

Failure of Title: Should any oil and gas interest or lease, or interest therein, be lost, through
failure of title, which loss results in a reduction of interest from that shown on Exhibit "A", this agreement, nevertheless, shall continue in force as to all remaining oil and gas leases and interests, and
(a) The party whose oil and gas lease or interest is affected by the title failure shall bear alone
the entire loss and it shall not be entitled to recover from Operator or the other parties any development

or operating costs which it may have theretofore paid, but there shall be no monetary liability on its 1 2 part to the other parties hereto for drilling, development, operating or other similar costs by reason of 3 such title failure; and

(b) There shall be no retroactive adjustment of expenses incurred or revenues received from the 4 operation of the interest which has been lost, but the interests of the parties shall be revised on an acre-5 age basis, as of the time it is determined finally that title failure has occurred, so that the interest of 6 the party whose lease or interest is affected by the title failure will thereafter be reduced in the Contract 7 Area by the amount of the interest lost; and 8

(c) If the proportionate interest of the other parties hereto in any producing well theretofore drilled 9 10 on the Contract Area is increased by reason of the title failure, the party whose title has failed shall receive the proceeds attributable to the increase in such interests (less costs and burdens attributable 11 thereto) until it has been reimbursed for unrecovered costs paid by it in connection with such well; 12 13 and

(d) Should any person not a party to this agreement, who is determined to be the owner of any in-14 terest in the title which has failed, pay in any manner any part of the cost of operation, development, 15 or equipment, such amount shall be paid to the party or parties who bore the costs which are so refund-16 17 ed; and

(e) Any liability to account to a third party for prior production of oil and gas which arises by 18 reason of title failure shall be borne by the party or parties in the same proportions in which they shared 19 20 in such prior production; and

(f) No charge shall be made to the joint account for legal expenses, fees or salaries, in connection 21 with the defense of the interest claimed by any party hereto, it being the intention of the parties 22 hereto that each shall defend title to its interest and bear all expenses in connection therewith. 23

25 2. Loss by Non-Payment or Erroneous Payment of Amount Due: If, through mistake or oversight, any rental, shut-in well payment, minimum royalty or royalty payment, is not paid or is erroneously 26 27 paid, and as a result a lease or interest therein terminates, there shall be no monetary liability against 28 the party who failed to make such payment. Unless the party who failed to make the required payment 29 secures a new lease covering the same interest within ninety (90) days from the discovery of the fail-30 ure to make proper payment, which acquisition will not be subject to Article VIII.B., the interests of 31 the parties shall be revised on an acreage basis, effective as of the date of termination of the lease involved, and the party who failed to make proper payment will no longer be credited with an interest in 32 33 the Contract Area on account of ownership of the lease or interest which has terminated. In the event 34 the party who failed to make the required payment shall not have been fully reimbursed, at the time of 35 the loss, from the proceeds of the sale of oil and gas attributable to the lost interest, calculated on an 36 acreage basis, for the development and operating costs theretofore paid on account of such interest, it 37 shall be reimbursed for unrecovered actual costs theretofore paid by it (but not for its share of the 38 cost of any dry hole previously drilled or wells previously abandoned) from so much of the following 39 as is necessary to effect reimbursement:

40 (a) Proceeds of oil and gas, less operating expenses, theretofore accrued to the credit of the lost 41 interest, on an acreage basis, up to the amount of unrecovered costs;

42 (b) Proceeds, less operating expenses, thereafter accrued attributable to the lost interest on an 43 acreage basis, of that portion of oil and gas thereafter produced and marketed (excluding production 44 from any wells thereafter drilled) which, in the absence of such lease termination, would be attributable 45 to the lost interest on an acreage basis, up to the amount of unrecovered costs, the proceeds of said 46 portion of the oil and gas to be contributed by the other parties in proportion to their respective in-47 terests; and

48 (c) Any monies, up to the amount of unrecovered costs, that may be paid by any party who is, or 49 becomes, the owner of the interest lost, for the privilege of participating in the Contract Area or be-50 coming a party to this agreement.

52 3. Other Losses: All losses incurred, other than those set forth in Articles IV.B.1. and IV.B.2. 53 above, shall not be considered failure of title but shall be joint losses and shall be borne by all parties 54 in proportion to their interests. There shall be no readjustment of interests in the remaining portion of 55 the Contract Area.

If Operator terminates its legal existence, no longer owns an interest in the 4 Contract Area, or is no longer capable of serving as Operator, it shall cease to be Operator without any 5 6 action by Non-Operator, except the selection of a successor. Operator may be removed if it fails or 7 refuses to carry out its duties hereunder, or becomes insolvent, bankrupt or is placed in receivership, by the affirmative vote of two (2) or more Non-Operators owning a majority interest based on owner-8 ship as shown on Exhibit "A", and not on the number of parties remaining after excluding the voting 9 10 interest of Operator. Proposed Operations: Should any party hereto desire to drill any well on the Contract Area 3 4 other than the well provided for in Article VI.A., or to rework, deepen or plug back a dry hole drilled at the joint expense of all parties or a well jointly owned by all the parties and not then producing 5 in paying quantities, the party desiring to drill, rework, deepen or plug back such a well shall give the 6 7 other parties written notice of the proposed operation, specifying the work to be performed, the location, proposed depth, objective formation and the estimated cost of the operation. The parties receiv-8 ing such a notice shall have thirty (30) days after receipt of the notice within which to notify the 9 parties wishing to do the work whether they elect to participate in the cost of the proposed operation. 10 If a drilling rig is on location, notice of proposal to rework, plug back or drill deeper may be given 11 by telephone and the response period shall be limited to forty-eight (48) hours, exclusive of Saturday, 12Sunday or legal holidays. In the case of any reworking, plugging back or deeper drilling operation, the Consenting Parties shall be permitted to use, free of cost, all casing, tubing and other equipment in the well, but the ownership of all such equipment shall remain unchanged; and upon abandonment of a well after such reworking, plugging back or deeper drilling, the Consenting Parties shall account for all such equipment to the owners thereof, with each party receiving its proportionate part in kind or in value, less cost of salvage.

Within sixty (60) days after the completion of any operation under this Article, the party con-26 27 ducting the operations for the Consenting Parties shall furnish each Non-Consenting Party with an in-28 ventory of the equipment in and connected to the well, and an itemized statement of the cost of drilling, deepening, plugging back, testing, completing, and equipping the well for production; or, at its option, 29 30 the operating party, in lieu of an itemized statement of such costs of operation, may submit a detailed 31 statement of monthly billings. Each month thereafter, during the time the Consenting Parties are being 32 reimbursed as provided above, the Party conducting the operations for the Consenting Parties shall furn-33 ish the Non-Consenting Parties with an itemized statement of all costs and liabilities incurred in the 34 operation of the well, together with a statement of the quantity of oil and gas produced from it and the 35 amount of proceeds realized from the sale of the well's working interest production during the preceding 36 month. In determining the quantity of oil and gas produced during any month, Consenting Parties 37 shall use industry accepted methods such as, but not limited to, metering or periodic well tests. Any 38 amount realized from the sale or other disposition of equipment newly acquired in connection with any 39 such operation which would have been owned by a Non-Consenting Party had it participated therein 40 shall be credited against the total unreturned costs of the work done and of the equipment purchased, in determining when the interest of such Non-Consenting Party shall revert to it as above provided; 41 42 and if there is a credit balance, it shall be paid to such Non-Consenting party. 43

If and when the Consenting Parties recover from a Non-Consenting Party's relinquished interest 44 45 the amounts provided for above, the relinquished interests of such Non-Consenting Party shall auto-46 matically revert to it, and, from and after such reversion, such Non-Consenting Party shall own the same interest in such well, the material and equipment in or pertaining thereto, and the production there-47 48 from as such Non-Consenting Party would have been entitled to had it participated in the drilling, reworking, deepening or plugging back of said well. Thereafter, such Non-Consenting Party shall be 49 charged with and shall pay its proportionate part of the further costs of the operation of said well in 50 51 accordance with the terms of this agreement and the Accounting Procedure, attached hereto. 52

66 Each party shall have the right to take in kind or separately dispose of its proportionate share of all oil and gas produced from 67 the Contract Area, exclusive of production which may be used in development and producing operations and in preparing and 68 treating oil for marketing purposes and production unavoidably lost. Any extra expenditure incurred in the taking in kind or separate 69 disposition by any party of its proportionate share of the production shall be borne by such party. Any party taking its share of 69 production in kind shall be required to pay for only its proportionate share of such part of Operator's surface facilities which it uses.

Each party electing to take in kind or separately dispose of its proportionate share of the production from the Contract Area shall keep accurate records of the volume, selling price, royalty and taxes relative to its share of production. Non-Operators shall, upon request, furnish Operator with true and complete copies of the records required to be kept thereunder whenever, under the terms of this agreement or any agreement executed in connection herewith, it is necessary for Operator to obtain said information. Any information furnished to Operator hereunder shall be used by Operator only to the extent necessary to carry out its duties as Operator and shall otherwise be kept confidential.

Each party shall execute such division orders and contracts as may be necessary for the sale of its interest in production from the Contract Area, and, except as provided in Article VII.B., shall be entitled to receive payment direct from the purchaser thereof for its share of all production.

8 In the event any party shall fail to make the arrangements necessary to take in kind or separately dispose of its proportionate share of the oil and gas produced from the Contract Area, Operator shall have 9 the right, subject to the revocation at will by the party owning it, but not the obligation, to purchase such 10 oil and gas or sell it to others at any time and from time to time, for the account of the non-taking 11 party at the best price obtainable in the area for such production. Any such purchase or sale by Op-12 erator shall be subject always to the right of the owner of the production to exercise at any time its 13 14 right to take in kind, or separately dispose of, its share of all oil and gas not previously delivered to a purchaser. Any purchase or sale by Operator of any other party's share of oil and gas shall be only for 15 such reasonable periods of time as are consistent with the minimum needs of the industry under the 16 particular circumstances, but in no event for a period in excess of one (1) year. Notwithstanding the 17 foregoing, Operator shall not make a sale, including one into interstate commerce, of any other party's 18 share of gas production without first giving such other party thirty (30) days notice of such intended 19 20 sale.

In the event any party hereto is not at any time taking or marketing its share of gas production and Operator is either (i) unwilling to purchase or sell or (ii) unable to obtain the prior written consent to purchase or sell such party's share of gas production, or in the event any party has contracted to sell its share of gas produced from the Contract Area to a purchaser which does not at any time while this agreement is in effect take the full share of gas attributable to the interest of such party, then in any such event the terms and conditions of the Gas Balancing Agreement attached hereto as Exhibit "E" and incorporated herein shall automatically become effective.

29 D. Access to Contract Area and Information:

31 Each party shall have access to the Contract Area at all reasonable times, at its sole risk to inspect or observe operations, and shall have access at reasonable times to information pertaining to the de-32 33 velopment or operation thereof, including Operator's books and records relating thereto. Operator, upon request, shall furnish each of the other parties with copies of all forms or reports filed with govern-34 mental agencies, daily drilling reports, well logs, tank tables, daily gauge and run tickets and reports 35 36 of stock on hand at the first of each month, and shall make available samples of any cores or cuttings taken from any well drilled on the Contract Area. The cost of gathering and furnishing information to 37 Non-Operator, other than that specified above, shall be charged to the Non-Operator that requests the 38 39 information.

41 E. Abandonment of Wells:

43 1. Abandonment of Dry Holes: Except for any well drilled pursuant to Article VI.B.2., any well which has been drilled under the terms of this agreement and is proposed to be completed as a dry hole 44 shall not be plugged and abandoned without the consent of all parties. Should Operator, after diligent 45 46 effort, be unable to contact any party, or should any party fail to reply within forty-eight (48) hours 47 (exclusive of Saturday, Sunday or legal holidays) after receipt of notice of the proposal to plug and abandon such well, such party shall be deemed to have consented to the proposed abandonment. All 48 such wells shall be plugged and abandoned in accordance with applicable regulations and at the cost, 49 50 risk and expense of the parties who participated in the cost of drilling of such well. Any party who objects to the plugging and abandoning such well shall have the right to take over the well and conduct 51 52 further operations in search of oil and/or gas subject to the provisions of Article VI.B.

2. Abandonment of Wells that have Produced: Except for any well which has been drilled or re-54 worked pursuant to Article VI.B.2. hereof for which the Consenting Parties have not been fully reim-55 bursed as therein provided, any well which has been completed as a producer shall not be plugged and 56 57 abandoned without the consent of all parties. If all parties consent to such abandonment, the well shall be plugged and abandoned in accordance with applicable regulations and at the cost, risk and expense 58 59 of all the parties hereto. If, within thirty (30) days after receipt of notice of the proposed abandonment of such well, all parties do not agree to the abandonment of any well, those wishing to continue its op-60 eration shall tender to each of the other parties its proportionate share of the value of the well's salvable 61 62 material and equipment, determined in accordance with the provisions of Exhibit "C", less the estimated cost of salvaging and the estimated cost of plugging and abandoning. 63 Any party's failure to timely respond within said thirty (30) days shall be deemed to consent to abandonment. Each abandoning party shall assign to the non-64 abandoning parties, without warranty, express or implied, as to title or as to quantity, quality, or fitness for use of the equipment and 65 material, all of its interest in the well and related equipment, together with its interest in the leasehold estate. If the interest of the 66 abandoning party is or includes an oil and gas interest, such party shall execute and deliver to the non-abandoning party or parties an 67 oil and gas lease, limited to the interval or intervals of the formation or formations with the Contract Area for a term of one year and 68 so long thereafter as oil and or gas is produced from the interval or intervals of the formation or formations covered thereby, such 69

lease to be on the form attached as Exhibit "B". The assignments or leases so limited shall encompass the "drilling unit" upon which the well is located. The payments by, and the assignments or leases to, the assignees shall be in a ratio based upon the relationship of their respective percentages of participation in the Contract Area to the aggregate of the percentages of participation in the Contract Area of all assignees. There shall be no readjustment of interest in the remaining portion of the Contract Area.

8 Thereafter, abandoning parties shall have no further responsibility, liability, or interest in the operation of or production from the well in the interval or intervals then open other than the royalties 9 retained in any lease made under the terms of this Article. Upon request, Operator shall continue to 10 operate the assigned well for the account of the non-abandoning parties at the rates and charges con-11 12 templated by this agreement, plus any additional cost and charges which may arise as the result of the separate ownership of the assigned well. 13

ARTICLE VII. **EXPENDITURES AND LIABILITY OF PARTIES**

A. Liability of Parties:

The liability of the parties shall be several, not joint or collective. Each party shall be responsible only for its obligations, and shall be liable only for its proportionate share of the costs of developing and operating the Contract Area. Accordingly, the liens granted among the parties in Article VII.B. are 22 given to secure only the debts of each severally. It is not the intention of the parties to create, nor shall this agreement be construed as creating, a mining or other partnership or association, or to render the parties liable as partners.

27 **B.** Liens and Payment Defaults:

Each Non-Operator grants to Operator a lien upon its oil and gas rights in the Contract Area, and a 29 security interest in its share of oil and/or gas when extracted and its interest in all equipment, to secure 30 payment of its share of expense, together with interest thereon at the rate provided in the Accounting 31 Procedure attached hereto as Exhibit "C". To the extent that Operator has a security interest under the 32 Uniform Commercial Code of the State, Operator shall be entitled to exercise the rights and remedies 33 of a secured party under the Code. The bringing of a suit and the obtaining of judgment by Operator 34 for the secured indebtedness shall not be deemed an election of remedies or otherwise affect the lien 35 36 rights or security interest as security for the payment thereof. In addition, upon default by any Non-37 Operator in the payment of its share of expense, Operator shall have the right, without prejudice to other rights or remedies, to collect from the purchaser the proceeds from the sale of such Non-Operator's 38 share of oil and/or gas until the amount owed by such Non-Operator, including reasonable attorney fees in the event of suit to collect 39 any delinquency, plus interest has been paid. Each purchaser shall be entitled to rely upon Operator's written statement concerning 40 the amount of any default. Operator grants a like lien and security interest to the Non-Operators to secure payment of Operator's 41 proportionate share of expense. 42

44 If any party fails or is unable to pay its share of expense within sixty (60) days after rendition of 45 a statement therefor by Operator, the non-defaulting parties, including Operator, shall, upon request by 46 Operator, pay the unpaid amount in the proportion that the interest of each such party bears to the in-47 terest of all such parties. Each party so paying its share of the unpaid amount shall, to obtain reimburse-48 ment thereof, be subrogated to the security rights described in the foregoing paragraph. 49

Operator shall keep an accurate 56 record of the joint account hereunder, showing expenses incurred and charges and credits made and 57 received.

59 Operator, at its election, shall have the right from time to time to demand and receive from the other parties payment in advance of their respective shares of the estimated amount of the expense to 60 61 be incurred in operations hereunder during the next succeeding month, which right may be exercised only 62 by submission to each such party of an itemized statement of such estimated expense, together with 63 an invoice for its share thereof. Each such statement and invoice for the payment in advance of estimated expense shall be submitted on or before the 20th day of the next preceding month. Each party 64 65 shall pay to Operator its proportionate share of such estimate within fifteen (15) days after such estimate and invoice is received. If any party fails to pay its share of said estimate within said time, the 66 amount due shall bear interest as provided in Exhibit "C" until paid. Proper adjustment shall be 67 made monthly between advances and actual expense to the end that each party shall bear and pay its 68 69 proportionate share of actual expenses incurred, and no more. 70

1. <u>Drill or Deepen</u>: Without the consent of all parties, no well shall be drilled or deepened, except any well drilled or deepened pursuant to the provisions of Article VI.B.2. of this Agreement, it being understood that the consent to the drilling or deepening shall include:

- Option-No.-1: All-necessary expenditures for the drilling or deepening, testing, completing and equipping of the well, including necessary tankage and/or surface facilities.

X Option No. 2: All necessary expenditures for the drilling or deepening and testing of the well. When 10 11 such well has reached its authorized depth, and all tests have been completed, Operator shall give immediate notice to the Non-Operators who have the right to participate in the completion costs. The parties 12 receiving such notice shall have forty-eight (48) hours (exclusive of Saturday, Sunday and legal holi-13 14 days) in which to elect to participate in the setting of casing and the completion attempt. Such election, when made, shall include consent to all necessary expenditures for the completing and equipping of such 15 well, including necessary tankage and/or surface facilities. Failure of any party receiving such notice 16 to reply within the period above fixed shall constitute an election by that party not to participate in 17 the cost of the completion attempt. If one or more, but less than all of the parties, elect to set pipe and 18 to attempt a completion, the provisions of Article VI.B.2. hereof (the phrase "reworking, deepening or 19 plugging back" as contained in Article VI.B.2. shall be deemed to include "completing") shall apply to 20 21 the operations thereafter conducted by less than all parties.

23 2. <u>Rework or Plug Back</u>: Without the consent of all parties, no well shall be reworked or plugged 24 back except a well reworked or plugged back pursuant to the provisions of Article VI.B.2. of this agree-25 ment, it being understood that the consent to the reworking or plugging back of a well shall include 26 consent to all necessary expenditures in conducting such operations and completing and equipping of 27 said well, including necessary tankage and/or surface facilities.

3. Other Operations: Operator shall not undertake any single project reasonably estimated to require 29 an expenditure in excess of FORTY THOUSAND----- Dollars (\$ 40,000.00 30) 31 except in connection with a well, the drilling, reworking, deepening, completing, recompleting, or plugging back of which has been previously authorized by or pursuant to this agreement; provided, how-32 33 ever, that, in case of explosion, fire, flood or other sudden emergency, whether of the same or different 34 nature, Operator may take such steps and incur such expenses as in its opinion are required to deal with the emergency to safeguard life and property but Operator, as promptly as possible, shall report the emer-35 gency to the other parties. If Operator prepares "Authority for Expenditures" for its own use, 36 Operator, upon request, shall furnish copies of its "Authority for Expenditures" for any single project 37 38 _ Dollars (\$ <u>25,000.00</u> ___). 39

40 E. Royalties, Overriding Royalties and Other Payments:

42 Each party shall pay or deliver, or cause to be paid or delivered, all royalties to the extent of 43 <u>1/8 of 8/8ths</u> due on its share of production and shall hold the other parties free 44 from any liability therefor. If the interest of any party in any oil and gas lease covered by this agree-45 ment is subject to any royalty, overriding royalty, production payment, or other charge over and above 46 the aforesaid royalty, such party shall assume and alone bear all such obligations and shall account 47 for or cause to be accounted for, such interest to the owners thereof.

No party shall ever be responsible, on any price basis higher than the price received by such party, to any other party's lessor or royalty owner, and if any such other party's lessor or royalty owner should demand and receive settlements on a higher price basis, the party contributing such lease shall bear the royalty burden insofar as such higher price is concerned.

It is recognized by the parties hereto that in addition to each party's share of working interest production as shown in Exhibit "A", such party shall have the right, subject to existing contracts, to market the royalty gas attributable to each lease which it contributes to the Contract Area and to receive payments due for such royalty gas produced from or allocated to such lease or leases. It is agreed that, regardless of whether each party markets or contracts for its share of gas, including the royalty gas under the leases which it contributed to the Contract Area, such party agrees to pay or cause to be paid to the royalty owners under its lease or leases the proceeds attributable to their respective royalty interest and to hold all other parties hereto harmless for its failure to do so.

54 F. Rentals, Shut-in Well Payments and Minimum Royalties:

Rentals, shut-in well payments and minimum royalties which may be required under the terms of 56 57 any lease shall be paid by the party or parties who subjected such lease to this agreement at its or their 58 expense. In the event two or more parties own and have contributed interests in the same lease to this 59 agreement, such parties may designate one of such parties to make said payments for and on behalf of all such parties. Any party may request, and shall be entitled to receive, proper evidence of all such pay-60 61 ments. In the event of failure to make proper payment of any rental, shut-in well payment or minimum 62 royalty through mistake or oversight where such payment is required to continue the lease in force, any loss which results from such non-payment shall be borne in accordance with the provisions of Article 63 64 IV.B.2.

Operator shall notify Non-Operator of the anticipated completion of a shut-in gas well or the shutting in or return to production of a producing gas well, at least five (5) days (excluding Saturday Sunday and holidays), or at the earliest opportunity permitted by circumstances, prior to taking such action, but assumes no liability for failure to do so. In the event of failure by Operator to so notify Non-Operator, the loss of any lease contributed hereto by Non-Operator for failure to make timely payments of any shut-in well payment shall be borne jointly by the parties hereto under the provisions of ArticleIV.B.3.

Beginning with the first calendar year after the effective date hereof, Operator shall render for ad 6 7 valorem taxation all property subject to this agreement which by law should be rendered for such taxes, and it shall pay all such taxes assessed thereon before they become delinquent. Prior to the ren-8 9 dition date, each Non-Operator shall furnish Operator information as to burdens (to include, but not be limited to, royalties, overriding royalties and production payments) on leases and oil and gas interests con-10 tributed by such Non-Operator. If the assessed valuation of any leasehold estate is reduced by reason of its 11 being subject to outstanding excess royalties, overriding royalties or production payments, the reduction in 12ad valorem taxes resulting therefrom shall inure to the benefit of the owner or owners of such leasehold 13 estate, and Operator shall adjust the charge to such owner or owners so as to reflect the benefit of such 14 reduction. Operator shall bill other parties for their proportionate share of all tax payments in the man-15 ner provided in Exhibit "C". 16

If Operator considers any tax assessment improper, Operator may, at its discretion, protest within the time and manner prescribed by law, and prosecute the protest to a final determination, unless all parties agree to abandon the protest prior to final determination. During the pendency of administrative or judicial proceedings, Operator may elect to pay, under protest, all such taxes and any interest and penalty. When any such protested assessment shall have been finally determined, Operator shall pay the tax for the joint account, together with any interest and penalty accrued, and the total cost shall then be assessed against the parties, and be paid by them, as provided in Exhibit "C".

Each party shall pay or cause to be paid all production, severance, gathering and other taxes imposed upon or with respect to the production or handling of such party's share of oil and/or gas produced under the terms of this agreement.

30 H. Insurance:

At all times while operations are conducted hereunder, Operator shall comply with the Workmen's 32 Compensation Law of the State where the operations are being conducted; provided, however, that Op-33 erator may be a self-insurer for liability under said compensation laws in which event the only charge 34 that shall be made to the joint account shall be an amount equivalent to the premium which would have 35 been paid had such insurance been obtained. Operator shall also carry or provide insurance for the 36 benefit of the joint account of the parties as outlined in Exhibit "D", attached to and made a part hereof. 37 38 Operator shall require all contractors engaged in work on or for the Contract Area to comply with the Workmen's Compensation Law of the State where the operations are being conducted and to maintain 39 40 such other insurance as Operator may require.

ARTICLE VIII. ACQUISITION, MAINTENANCE OR TRANSFER OF INTEREST

49 A. Surrender of Leases:

51 The leases covered by this agreement, insofar as they embrace acreage in the Contract Area, shall 52 not be surrendered in whole or in part unless all parties consent thereto. However, no consent shall be 53 necessary to release a lease which has expired or otherwise terminated.

54 However, should any party desire to surrender its interest in any lease or in any portion thereof, and 55 other parties do not agree or consent thereto, the party desiring to surrender shall assign, without express or implied warranty of title, all of its interest in such lease, or portion thereof, and any well, material and 56 57 equipment which may be located thereon and any rights in production thereafter secured, to the parties 58 not desiring to surrender it. If the interest of the assigning party includes an oil and gas interest, the as-59 signing party shall execute and deliver to the party or parties not desiring to surrender an oil and gas lease covering such oil and gas interest for a term of one year and so long thereafter as oil and/or gas 60 61 is produced from the land covered thereby, such lease to be on the form attached hereto as Exhibit "B". Upon such assignment, the assigning party shall be relieved from all obligations thereafter accruing, 62 but not theretofore accrued, with respect to the acreage assigned and the operation of any well thereon, 63 64 and the assigning party shall have no further interest in the lease assigned and its equipment and pro-65 duction other than the royalties retained in any lease made under the terms of this Article, The parties assignee shall pay to the party assignor the reasonable salvage value of the latter's interest in any wells 66 67 and equipment on the assigned acreage. The value of all material shall be determined in accordance with the provisions of Exhibit "C", less the estimated cost of salvaging and the estimated cost of plug-68 69 ging and abandoning. If the assignment is in favor of more than one party, the assigned interest shall 70 Anorth at transition of Papers on Landson

be shared by the parties assignee in the proportions that the interest of each bears to the interest of all
 parties assignee.

Any assignment or surrender made under this provision shall not reduce or change the assignor's or surrendering parties' interest, as it was immediately before the assignment, in the balance of the Contract Area; and the acreage assigned or surrendered, and subsequent operations thereon, shall not thereafter be subject to the terms and provisions of this agreement.

B. Renewal or Extension of Leases:

If any party secures a renewal of any oil and gas lease subject to this Agreement, all other parties shall be notified promptly, and shall have the right for a period of thirty (30) days following receipt of such notice in which to elect to participate in the ownership of the renewal lease, insofar as such lease affects lands within the Contract Area, by paying to the party who acquired it their several proper proportionate shares of the acquisition cost allocated to that part of such lease within the Contract Area, which shall be in proportion to the interests held at that time by the parties in the Contract Area.

18 If some, but less than all, of the parties elect to participate in the purchase of a renewal lease, it 19 shall be owned by the parties who elect to participate therein, in a ratio based upon the relationship of 20 their respective percentage of participation in the Contract Area to the aggregate of the percentages 21 of participation in the Contract Area of all parties participating in the purchase of such renewal lease. 22 Any renewal lease in which less than all parties elect to participate shall not be subject to this agreement. 23

Each party who participates in the purchase of a renewal lease shall be given an assignment without warranty of its proportionate interest therein by the acquiring party.

The provisions of this Article shall apply to renewal leases whether they are for the entire interest covered by the expiring lease or cover only a portion of its area or an interest therein. Any renewal lease taken before the expiration of its predecessor lease, or taken or contracted for within six (6) months after the expiration of the existing lease shall be subject to this provision; but any lease taken or contracted for more than six (6) months after the expiration of an existing lease shall not be deemed a renewal lease and shall not be subject to the provisions of this agreement.

For the purpose of maintaining uniformity of ownership in the oil and gas leasehold interests covered by this agreement, and notwithstanding any other provisions to the contrary, no party shall sell, encumber, transfer or make other disposition of its interest in the leases embraced within the Contract Area and in wells, equipment and production unless such disposition covers either:

1. the entire interest of the party in all leases and equipment and production; or

2. an equal undivided interest in all leases and equipment and production in the Contract Area.

Every such sale, encumbrance, transfer or other disposition made by any party shall be made expressly subject to this agreement, and shall be made without prejudice to the right of the other parties.

If, at any time the interest of any party is divided among and owned by four or more co-owners, 24 Operator, at its discretion, may require such co-owners to appoint a single trustee or agent with full 25 authority to receive notices, approve expenditures, receive billings for and approve and pay such party's 26 share of the joint expenses, and to deal generally with, and with power to bind, the co-owners of such 27 party's interests within the scope of the operations embraced in this agreement; however, all such 28 co-owners shall have the right to enter into and execute all contracts or agreements for the disposition 29 of their respective shares of the oil and gas produced from the Contract Area and they shall have the 30 right to receive, separately, payment of the sale proceeds hereof. 31

F. Waiver of Right to Partition:

If permitted by the laws of the state or states in which the property covered hereby is located, each party hereto owning an undivided interest in the Contract Area waives any and all rights it may have to partition and have set aside to it in severalty its undivided interest therein.

39 G-Preferential-Right-to-Purchase:

41 Should any party desire to sell all or any part of its interests under this agreement, or its rights and interests in the Contract Area, it shall promptly give written notice to the other parties, with full infor-42 43 mation concerning its proposed sale, which shall include the name and address of the prospective pur-44 chaser (who must be ready, willing and able to purchase), the purchase price, and all other terms of 45 the offer. Notwithstanding any pro-58 59 visions herein that the rights and liabilities hereunder are several and not joint or collective, or that this agreement and operations hereunder shall not constitute a partnership, if, for Federal income tax pur-60 poses, this agreement and the operations hereunder are regarded as a partnership, each party hereby 61 62 affected elects to be excluded from the application of all of the provisions of Subchapter "K", Chapter 1, Subtitle "A", of the Internal Revenue Code of 1986, as permitted and authorized by Section 761 of 63 the Code and the regulations promulgated thereunder. Should there be any requirement that each party hereby affected give further evidence of this election, each such party shall execute such documents and furnish such other evidence as may be 69 required by the Federal Internal Revenue Service or as may be necessary to evidence this election. If a claim is made against any party or if any party is sued on account of any matter arising from operations hereunder over which such individual has no control because of the rights given 21 Operator by this agreement, the party shall immediately notify Operator, and the claim or suit shall be treated as any other claim or suit involving operations hereunder. 22

ARTICLE XI. FORCE MAJEURE

If any party is rendered unable, wholly or in part, by force majeure to carry out its obligations 27 under this agreement, other than the obligation to make money payments, that party shall give to all 28 other parties prompt written notice of the force majeure with reasonably full particulars concerning it; 29 thereupon, the obligations of the party giving the notice, so far as they are affected by the force majeure, 30 shall be suspended during, but no longer than, the continuance of the force majeure. The affected party 31 32 shall use all reasonable diligence to remove the force majeure situation as quickly as practicable.

The requirement that any force majeure shall be remedied with all reasonable dispatch shall not 34 require the settlement of strikes, lockouts, or other labor difficulty by the party involved, contrary to its 35 wishes; how all such difficulties shall be handled shall be entirely within the discretion of the party 36 37 concerned.

The term "force majeure", as here employed, shall mean an act of God, strike, lockout, or other 39 40 industrial disturbance, act of the public enemy, war, blockade, public riot, lightning, fire, storm, flood, 41 explosion, governmental action, governmental delay, restraint or inaction, unavailability of equipment, 42 and any other cause, whether of the kind specifically enumerated above or otherwise, which is not 43 reasonably within the control of the party claiming suspension.

ARTICLE XIL NOTICES

48 All notices authorized or required between the parties, and required by any of the provisions of 49 this agreement, unless otherwise specifically provided, shall be given in writing by United States mail 50 or Western Union telegram, postage or charges prepaid, or by telefax, and addressed to the party to whom the notice is given at the addresses listed on Exhibit "A". The originating notice given under any 51 provision hereof shall be deemed given only when received by the party to whom such notice is directed, 52 and the time for such party to give any notice in response thereto shall run from the date the originat-53 ing notice is received. 
Notwithstanding any other provisions herein, if during the term of this agreement, a well is required to be drilled, deepened, 42 reworked, plugged back, sidetracked, or recompleted, or any other operation that may be required in order to (1) continue a lease or 43 leases in force and effect, or (2) maintain a unitized area or any portion thereof in force and effect, or (3) earn or preserve an interest 44 in and to oil and/or gas and other minerals which may be owned by a third party of which, failing in such operation, may revert to a 45 third party, or, (4) comply with an order issued by a regulatory body having jurisdiction in the premises, failing in which certain rights would terminate, the following shall apply. Should less than all of the parties hereto elect to participate and pay their 46 proportionate part of the costs to be incurred in such operation, those parties desiring to participate shall have the right to do so at 47 their sole cost, risk, and expense. Promptly following the conclusion of such operation, each of those parties not participating agree 48 to execute and deliver an appropriate assignment to the total interest of each non-participating party in and to the lease, leases, or 49 rights which would have terminated or which otherwise may have been preserved by virtue of such operation, and in and to the lease, 50 leases or rights within the balance of the drilling unit upon which the well was drilled, excepting, however, wells theretofore 51 completed and capable of producing in paying quantities. Such assignment shall be delivered to the participating parties in the proportion that they bore the expense attributable to the non-participating parties' interest. For the purpose of defining a required 52 operation under this provision, such operation will be deemed required if proposed within six (6) months prior to the date such rights 53 would terminate (including a Pugh Clause or Continuous Development Clause) or any extension thereof. 54

E. No production, whether oil or gas, may be sold from the lease acreage, or lands pooled therewith, to any party's subsidiaries, affiliates, or associates, without such selling party's written consent. All production sold from the lease acreage, or lands pooled therewith, will be an arm's length trade with a third party purchaser. It is expressly agreed if prior written consent is given to a party selling to themselves, its subsidiaries, affiliates, or associates, the other parties to the agreement will have the option to also sell to said purchaser, at the same or better price. In the event any party hereto, makes an arm's length trade with a third party purchaser, the remaining parties will have the option to also sell at the same or higher price.

F. Prior to commencement of any well drilled under this Agreement, each non-operator must tender to the operator its share of dry hole cost, as set out on Authority for Expenditure proposing such well.



G. In addition to the liens and security interest as provided herein, each Non-Operator to this Agreement, to secure payment of its share of expenses incurred under this Operating Agreement, grants Operator a lien on all of its right, title and interest now owned or hereafter acquired in the contract area including, but not limited to, the oil and gas leases, mineral estates and other mineral interests subject to this Operating Agreement and any properties now or hereafter pooled or unitized with any of the properties affected by such mineral interests; and all unsevered and unextracted oil, gas and other hydrocarbons that may be produced, obtained or secured from the lands covered and affected by such mineral interests. In addition to the rights and remedies afforded to Operator pursuant to the terms hereof, or at law or in equity, it is understood and agreed that each defaulting party grants to the Operator a contractual right of offset in and to all money, production proceeds from the sale of production and property of every kind or character of such defaulting party, now or at any time hereunder coming within Operator's custody or control, wheresoever located whether or not subject to the terms of the Agreement or any other agreement between Operator and defaulting party. Operator, may, at its election, at any time from time to time, reduce (or eliminate, as the case may be) any debt owing to it by any defaulting party by applying such defaulting party's money, proceeds or property in the custody or control of Operator to the balance owed on such debt and giving such defaulting party appropriate credit therefore. Any such amount so applied shall first be applied to any past due interest, if any, then to any costs, including attorney's fees, incurred by Operator in the collection of the proceeds or property, and then to the underlying debt. It is agreed and understood that Operator's contractual right of offset shall extend to and include all proceeds of production attributable to the defaulting party from any wells in which the defaulting party owns an interest. In addition to all rights and remedies afforded Operator under this agreement, in the event any debt owing by the defaulting party to Operator shall exceed any money, proceeds of sale of production, or property of such defaulting party as provided in the contractual right of offset as provided above, the Operator may elect to proceed and foreclose the lien of Operator against the interest of any defaulting party in the contract area.

ACCOUNTING PROCEDURE JOINT OPERATIONS

I. GENERAL PROVISIONS

1. Definitions

"Joint Property" shall mean the real and personal property subject to the agreement to which this Accounting Procedure is attached.

"Joint Operations" shall mean all operations necessary or proper for the development, operation, protection and maintenance of the Joint Property.

"Joint Account" shall mean the account showing the charges paid and credits received in the conduct of the Joint Operations and which are to be shared by the Parties.

"Operator" shall mean the party designated to conduct the Joint Operations.

"Non-Operators" shall mean the parties to this agreement other than the Operator.

"Parties" shall mean Operator and Non-Operators.

"First Level Supervisors" shall mean those employees whose primary function in Joint Operations is the direct supervision of other employees and/or contract labor directly employed on the Joint Property in a field operating capacity.

"Technical Employees" shall mean those employees having special and specific engineering, geological or other professional skills, and whose primary function in Joint Operations is the handling of specific operating conditions and problems for the benefit of the Joint Property.

"Personal Expenses" shall mean travel and other reasonable reimbursable expenses of Operator's employees.

"Material" shall mean personal property, equipment or supplies acquired or held for use on the Joint Property.

"Controllable Material" shall mean Material which at the time is so classified in the Material Classification Manual as most recently recommended by the Council of Petroleum Accountants Societies of North America.

2. Statement and Billings

Operator shall bill Non-Operators on or before the last day of each month for their proportionate share of the Joint Account for the preceding month. Such bills will be accompanied by statements which identify the authority for expenditure, lease or facility, and all charges and credits, summarized by appropriate classifications of investment and expense except that items of Controllable Material and unusual charges and credits shall be separately identified and fully described in detail.

3. Advances and Payments by Non-Operators

Unless otherwise provided for in the agreement, the Operator may require the Non-Operators to advance their share of estimated cash outlay for the succeeding month's operation. Operator shall adjust each monthly billing to reflect advances received from the Non-Operators.

Each Non-Operator shall pay its proportion of all bills within fifteen (15) days after receipt. If payment is not made within such time, the unpaid balance shall bear interest monthly at the rate of twelve percent (12%) per annum or the maximum contract rate permitted by the applicable usury laws in the state in which the Joint Property is located, whichever is the lesser, plus attorney's fees, court costs, and other costs in connection with the collection of unpaid amounts.

4. Adjustments

Payment of any such bills shall not prejudice the right of any Non-Operator to protest or question the correctness thereof; provided, however, all bills and statements rendered to Non-Operators by Operator during any calendar year shall conclusively be presumed to be true and correct after twenty-four (24) months following the end of any such calendar year, unless within the said twenty-four (24) month period a Non-Operator takes written exception thereto and makes claim on Operator for adjustment. No adjustment favorable to Operator shall be made unless it is made within the same prescribed period. The provisions of this paragraph shall not prevent adjustments resulting from a physical inventory of Controllable Material as provided for in Section V.

5. Audits

A. Non-Operator, upon notice in writing to Operator and all other Non-Operators, shall have the right to audit Operator's accounts and records relating to the Joint Account for any calendar year within the twenty-four (24) month period following the end of such calendar year; provided, however, the making of an audit shall not extend the time for the taking of written exception to and the adjustments of accounts as provided for in Paragraph 4 of this Section I. Where there are two or more Non-Operators, the Non-Operators shall make every reasonable effort to conduct joint or simultaneous audits in a manner which will result in a minimum of inconvenience to the Operator. Operator shall bear no portion of the Non-Operators' audit cost incurred under this paragraph unless agreed to by the Operator.

6. Approval by Non-Operators

Where an approval or other agreement of the Parties or Non-Operators is expressly required under other sections of this Accounting Procedure and if the agreement to which this Accounting Procedure is attached contains no contrary provisions in regard thereto, Operator shall notify all Non-Operators of the Operator's proposal, and the agreement or approval of a majority in interest of the Non-Operators shall be controlling on all Non-Operators.

II. DIRECT CHARGES

Operator shall charge the Joint Account with the following items:

1. Rentals and Royalties

- Lease rentals and royalties paid by Operator for the Joint Operations.
- 2. Labor
 - A. (1) Salaries and wages of Operator's field employees directly employed on the Joint Property in the conduct of Joint Operations.
 - (2) Salaries of First Level Supervisors in the field.
 - (3) Salaries and wages of Technical Employees directly employed on the Joint Property if such charges are excluded from the Overhead rates.
 - B. Operator's cost of holiday, vacation, sickness and disability benefits and other customary allowances paid to employees whose salaries and wages are chargeable to the Joint Account under Paragraph 2A of this Section II. Such costs under this Paragraph 2B may be charged on a "when and as paid basis" or by "percentage assessment" on the amount of salaries and wages chargeable to the Joint Account under Paragraph 2A of this Section II. If percentage assessment is used, the rate shall be based on the Operator's cost experience.
 - C. Expenditures or contributions made pursuant to assessments imposed by governmental authority which are applicable to Operator's costs chargeable to the Joint Account under Paragraphs 2A and 2B of this Section II.
 - D. Personal Expenses of those employees whose salaries and wages are chargeable to the Joint Account under Paragraph 2A of this Section II.

3. Employee Benefits

Operator's current costs of established plans for employees' group life insurance, hospitalization, pension, retirement, stock purchase, thrift, bonus, and other benefit plans of a like nature, applicable to Operator's labor cost chargeable to the Joint Account under Paragraphs 2A and 2B of this Section II shall be Operator's actual cost not to exceed twenty per cent (20%).

Material purchased or furnished by Operator for use on the Joint Property as provided under Section IV. Only such Material shall be purchased for or transferred to the Joint Property as may be required for immediate use and is reasonably practical and consistent with efficient and economical operations. The accumulation of surplus stocks shall be avoided.

5. Transportation

Transportation of employees and Material necessary for the Joint Operations but subject to the following limitations:

- If Material is moved to the Joint Property from the Operator's warehouse or other properties, no charge shall be made to the Joint Account for a distance greater than the distance from the nearest reliable supply store, recognized barge terminal, or railway receiving point where like material is normally available, unless agreed to by the Parties.
- B. If surplus Material is moved to Operator's warehouse or other storage point, no charge shall be made to the Joint Account for a distance greater than the distance to the nearest reliable supply store, recognized barge terminal, or railway receiving point unless agreed to by the Parties. No charge shall be made to the Joint Account for moving Material to other properties belonging to Operator, unless agreed to by the Parties.
- C. In the application of Subparagraphs A and B above, there shall be no equalization of actual gross trucking cost. of \$200 or less excluding accessorial charges.

6. Services

The cost of contract services, equipment and utilities provided by outside sources, except services excluded by Paragraph 9 of Section II and Paragraph 1. ii of Section III. The cost of professional consultant services and contract services of technical personnel directly engaged on the Joint Property if such charges are excluded from the Overhead rates. The cost of professional consultant services or contract services of technical personnel not directly engaged on the Joint Property shall not be charged to the Joint Account unless previously agreed to by the Parties.

7. Equipment and Facilities Furnished by Operator

- A. Operator shall charge the Joint Account for use of Operator owned equipment and facilities at rates commensurate with costs of ownership and operation. Such rates shall include costs of maintenance, repairs, other operating expense, insurance, taxes, depreciation, and interest on investment not to exceed eight per cent (8%) per annum. Such rates shall not exceed average commercial rates currently prevailing in the immediate area of the Joint Property.
- B.. In lieu of charges in Paragraph 7A above, Operator may elect to use average commercial rates prevailing in the immediate area of the Joint Property less 20%. For automotive equipment, Operator may elect to use rates published by the Petroleum Motor Transport Association.

8. Damages and Losses to Joint Property

All costs or expenses necessary for the repair or replacement of Joint Property made necessary because of damages or losses incurred by fire, flood, storm, theft, accident, or other cause, except those resulting from Operator's gross negligence or willful misconduct. Operator shall furnish Non-Operator written notice of damages or losses incurred as soon as practicable after a report thereof has been received by Operator.

9. Legal Expense

- A. Expense of handling, investigating and settling litigation or claims, discharging of liens, payment of judgments and amounts paid for settlement of claims incurred in or resulting from operations under the agreement or necessary to protect or recover the Joint Property, except that no charge for services of Operator's legal staff or fees or expense of outside attorneys shall be made unless previously agreed to by the Parties. All other legal expense is considered to be covered by the overhead provisions of Section III unless otherwise agreed to by the Parties, except as provided in Section I, Paragraph 3.
- 8 Expenses incurred by Operator in representing the Joint Property at hearings or proceedings before state or federal regulatory or administrative agencies. - 2 ---

10. Taxes

All taxes of every kind and nature assessed or levied upon or in connection with the Joint Property, the operation thereof, or the production therefrom, and which taxes have been paid by the Operator for the benefit of the Parties.

11. Insurance

Net premiums paid for insurance required to be carried for the Joint Operations for the protection of the Parties. In the event Joint Operations are conducted in a state in which Operator may act as self-insurer for Workmen's Compensation and/or Employers Liability under the respective state's laws, Operator may, at its election, include the risk under its self-insurance program and in that event, Operator shall include a charge at Operator's cost not to exceed manual rates.

12. Other Expenditures

Any other expenditure not covered or dealt with in the foregoing provisions of this Section II, or in Section III, and which is incurred by the Operator in the necessary and proper conduct of the Joint Operations.

III. OVERHEAD

1. Overhead - Drilling and Producing Operations

- i. As compensation for administrative, supervision, office services and warehousing costs, Operator shall charge drilling and producing operations on either:
 - (XX) Fixed Rate Basis, Paragraph 1A, or

() Percentage Basis, Paragraph 1B.

Unless otherwise agreed to by the Parties, such charge shall be in lieu of costs and expenses of all offices and salaries or wages plus applicable burdens and expenses of all personnel, except those directly chargeable under Paragraph 2A, Section II. The cost and expense of services from outside sources in connection with matters of taxation, traffic, accounting or matters before or involving governmental agencies shall be considered as included in the Overhead rates provided for in the above selected Paragraph of this Section III unless such cost and expense are agreed to by the Parties as a direct charge to the Joint Account.

ii. The salaries, wages and Personal Expenses of Technical Employees and/or the cost of professional consultant services and contract services of technical personnel directly employed on the Joint Property shall () shall not (XX) be covered by the Overhead rates.

- (2) Application of Overhead Fixed Rate Basis shall be as follows:
 - (a) Drilling Well Rate
 - [1] Charges for onshore drilling wells shall begin on the date the well is spudded and terminate on the date the drilling or completion rig is released, whichever is later, except that no charge shall be made during suspension of drilling operations for fifteen (15) or more consecutive days.
 - [2] Charges for offshore drilling wells shall begin on the date when drilling or completion equipment arrives on location and terminate on the date the drilling or completion equipment moves off location or rig is released, whichever occurs first, except that no charge shall be made during suspension of drilling operations for fifteen (15) or more consecutive days
 - [3] Charges for wells undergoing any type of workover or recompletion for a period of five (5) consecutive days or more shall be made at the drilling well rate. Such charges shall be applied for the period from date workover operations, with rig, commence through date of rig release, except that no charge shall be made during suspension of operations for fifteen (15) or more consecutive days.
 - (b) Producing Well Rates
 - [1] An active well either produced or injected into for any portion of the month shall be considered as a one-well charge for the entire month.
 - [2] Each active completion in a multi-completed well in which production is not commingled down hole shall be considered as a one-well charge providing each completion is considered a separate well by the governing regulatory authority.
 - [3] An inactive gas well shut in because of overproduction or failure of purchaser to take the production shall be considered as a one-well charge providing the gas well is directly connected to a permanent sales outlet.
 - [4] A one-well charge may be made for the month in which plugging and abandonment operations are completed on any well.
 - [5] All other inactive wells (including but not limited to inactive wells covered by unit allowable, lease allowable, transferred allowable, etc.) shall not qualify for an overhead charge.
- (3) The well rates shall be adjusted as of the first day of April each year following the effective date of the agreement to which this Accounting Procedure is attached. The adjustment shall be computed by multiplying the rate currently in use by the percentage increase or decrease in the average weekly earnings of Crude Petroleum and Gas Production Workers for the last calendar year compared to the calendar year preceding as shown by the index of average weekly earnings of Crude Petroleum and Gas Fields Production Workers as published by the United States Department of Labor, Bureau of Labor Statistics, or the equivalent Canadian index as published by Statistics Canada, as applicable. The adjusted rates shall be the rates currently in use, plus or minus the computed adjustment.

B. Overhead - Percentage Basis

(1) Operator shall charge the Joint Account at the following rates:

(a) Development

Percent (%) of the cost of Development of the Joint Property exclusive of costs provided under Paragraph 9 of Section II and all salvage credits.

(b) Operating

Percent (%) of the cost of Operating the Joint Property exclusive of costs provided under Paragraphs 1 and 9 of Section II, all salvage credits, the value of injected substances purchased for secondary recovery and all taxes and assessments which are levied, assessed and paid upon the mineral interest in and to the Joint Property.

(2) Application of Overhead - Percentage Basis shall be as follows:

For the purpose of determining charges on a percentage basis under Paragraph 1B of this Section III, development shall include all costs in connection with drilling, redrilling, deepening or any remedial operations on any or all wells involving the use of drilling crew and equipment; also, preliminary expenditures necessary in preparation for drilling and expenditures incurred in abandoning when the well is not completed as a producer, and original cost of construction or installation of fixed assets, the expansion of fixed assets and any other project clearly discernible as a fixed asset, except Major Construction as defined in Paragraph 2 of this Section III. All other costs shall be considered as Operating.

2. Overhead - Major Construction

To compensate Operator for overhead costs incurred in the construction and installation of fixed assets, the expansion of fixed assets, and any other project clearly discernible as a fixed asset required for the development and operation of the Joint Property, Operator shall either negotiate a rate prior to the beginning of construction, or shall charge the Joint Account for Overhead based on the following rates for any Major Construction project in excess of 25,000.00:

A. 5 % of total costs if such costs are more than \$25,000.00 but less than \$100,000.00; plus

- B. _3____% of total costs in excess of \$_100,000.00 but less than \$1,000,000; plus
- C. $2 \qquad \%$ of total costs in excess of \$1,000,000.

Total cost shall mean the gross cost of any one project. For the purpose of this paragraph, the component parts of a single project shall not be treated separately and the cost of drilling and workover wells shall be excluded.

3. Amendment of Rates

The Overhead rates provided for in this Section III may be amended from time to time only by mutual agreement between the Parties hereto if, in practice, the rates are found to be insufficient or excessive.

IV. PRICING OF JOINT ACCOUNT MATERIAL PURCHASES, TRANSFERS AND DISPOSITIONS

Operator is responsible for Joint Account Material and shall make proper and timely charges and credits for all material movements affecting the Joint Property. Operator shall provide all Material for use on the Joint Property; however, at Operator's option, such Material may be supplied by the Non-Operator. Operator shall make timely disposition of idle and/or surplus Material, such disposal being made either through sale to Operator or Non-Operator, division in kind, or sale to outsiders. Operator may purchase, but shall be under no obligation to purchase, interest of Non-Operators in surplus condition A or B Material. The disposal of surplus Controllable Material not purchased by the Operator shall be agreed to by the Parties.

1. Purchases

Material purchased shall be charged at the price paid by Operator after deduction of all discounts received. In case of Material found to be defective or returned to vendor for any other reason, credit shall be passed to the Joint Account when adjustment has been received by the Operator.

2. Transfers and Dispositions

Material furnished to the Joint Property and Material transferred from the Joint Property or disposed of by the Operator, unless otherwise agreed to by the Parties, shall be priced on the following bases exclusive of cash discounts:

A. New Material (Condition A)

- (1) Tubular goods, except line pipe, shall be priced at the current new price in effect on date of movement on a maximum carload or barge load weight basis, regardless of quantity transferred, equalized to the lowest published price f.o.b. railway receiving point or recognized barge terminal nearest the Joint Property where such Material is normally available.
- (2) Line Pipe
 - (a) Movement of less than 30,000 pounds shall be priced at the current new price, in effect at date of movement, as listed by a reliable supply store nearest the Joint Property where such Material is normally available.
 - (b) Movement of 30,000 pounds or more shall be priced under provisions of tubular goods pricing in Paragraph 2A (1) of this Section IV.
- (3) Other Material shall be priced at the current new price, in effect at date of movement, as listed by a reliable supply store or f.o.b. railway receiving point nearest the Joint Property where such Material is normally available.

B. Good Used Material (Condition B)

Material in sound and serviceable condition and suitable for reuse without reconditioning:

(1) Material moved to the Joint Property

(a) At seventy-five percent (75%) of current new price, as determined by Paragraph 2A of this Section IV.(2) Material moved from the Joint Property

(a) At seventy-five percent (75%) of current new price, as determined by Paragraph 2A of this Section IV, if Material was originally charged to the Joint Account as new Material, or

PADAN.

- (b) at sixty-five percent (65%) of current new price, as determined by Paragraph 2A of this Section IV, if Material was originally charged to the Joint Account as good used Material at seventy-five percent (75%) of current new price.
- The cost of reconditioning, if any, shall be absorbed by the transferring property.

C. Other Used Material (Condition C and D)

(1) Condition C

Material which is not in sound and serviceable condition and not suitable for its original function until after reconditioning shall be priced at fifty percent (50%) of current new price as determined by Paragraph 2A of this Section IV. The cost of reconditioning shall be charged to the receiving property, provided Condition C value plus cost of reconditioning does not exceed Condition B value.

(2) Condition D

All other Material, including junk, shall be priced at a value commensurate with its use or at prevailing prices. Material no longer suitable for its original purpose but usable for some other purpose, shall be priced on a basis comparable with that of items normally used for such other purpose. Operator may dispose of Condition D Material under procedures normally utilized by the Operator without prior approval of Non-Operators.

D. Obsolete Material

Material which is serviceable and usable for its original function but condition and/or value of such Material is not equivalent to that which would justify a price as provided above may be specially priced as agreed to by the Parties. Such price should result in the Joint Account being charged with the value of the service rendered by such Material.

E. Pricing Conditions

- (1) Loading and unloading costs may be charged to the Joint Account at the rate of fifteen cents (15¢) per hundred weight on all tubular goods movements, in lieu of loading and unloading costs sustained, when actual hauling cost of such tubular goods are equalized under provisions of Paragraph 5 of Section II.
- (2) Material involving erection costs shall be charged at applicable percentage of the current knocked-down price of new Material.

3. Premium Prices

Whenever Material is not readily obtainable at published or listed prices because of national emergencies, strikes or other unusual causes over which the Operator has no control, the Operator may charge the Joint Account for the required Material at the Operator's actual cost incurred in providing such Material, in making it suitable for use, and in moving it to the Joint Property; provided notice in writing is furnished to Non-Operators of the proposed charge prior to billing Non-Operators for such Material. Each Non-Operator shall have the right, by so electing and notifying Operator within ten days after receiving notice from Operator, to furnish in kind all or part of his share of such Material suitable for use and acceptable to Operator.

4. Warranty of Material Furnished by Operator

Operator does not warrant the Material furnished. In case of defective Material, credit shall not be passed to the Joint Account until adjustment has been received by Operator from the manufacturers or their agents.

V. INVENTORIES

The Operator shall maintain detailed records of Controllable Material.

1. Periodic Inventories, Notice and Representation

At reasonable intervals, Inventories shall be taken by Operator of the Joint Account Controllable Material. Written notice of intention to take inventory shall be given by Operator at least thirty (30) days before any inventory is to begin so that Non-Operators may be represented when any inventory is taken. Failure of Non-Operators to be represented at an inventory shall bind Non-Operators to accept the inventory taken by Operator.

2. Reconciliation and Adjustment of Inventories

Reconciliation of a physical inventory with the Joint Account shall be made, and a list of overages and shortages shall be furnished to the Non-Operators within six months following the taking of the inventory. Inventory adjustments shall be made by Operator with the Joint Account for overages and shortages, but Operator shall be held accountable only for shortages due to lack of reasonable diligence.

3. Special Inventories

Special Inventories may be taken whenever there is any sale or change of interest in the Joint Property. It shall be the duty of the party selling to notify all other Parties as quickly as possible after the transfer of interest takes place. In such cases, both the seller and the purchaser shall be governed by such inventory.

4. Expense of Conducting Periodic Inventories

The expense of conducting periodic Inventories shall not be charged to the Joint Account unless agreed to by the Parties.

EXHIBIT "D"

ATTACHED TO AND MADE A PART OF OPERATING AGREEMENT

ADDITIONAL INSURANCE PROVISIONS

Operator, during the term of this agreement, shall carry insurance for the benefit and at the expense of the parties hereto, as follows:

- (A) Workman's Compensation Insurance as contemplated by the state in which operations will be conducted, and Employer's Liability Insurance with limits of not less than \$1,000,000.00 per employee.
- (B) Public Liability Insurance:
 Bodily Injury and Property Damage \$1,000,000.00 single limit each occurrence.
- (C) Automobile Public Liability Insurance:
 Bodily Injury \$500,000.00 each person.
 \$1,000,000.00 each occurrence.

Property Damage - \$500,000.00 each accident.

(or)

Bodily Injury and Property Damage - \$1,000,000.00 combined single limit.

(D) Control of Well and Extra Expense - \$10,000,000.00 - Limit of Liability

Except as authorized by this Exhibit "D", Operator shall not make any charge to the joint account for insurance premiums. Losses not covered by Operator's insurance (or by insurance required by this agreement to be carried for the benefit and at the expense of the parties hereto) shall be charged to the joint account.

EXHIBIT "E"

GAS BALANCING AGREEMENT

The parties to the Operating Agreement to which this agreement is attached own the working interest in the gas rights underlying the lands covered by such agreement (the "Contract Area") in accordance with the percentages of participation as set forth in Exhibit "A" to the Operating Agreement (the "participation percentage").

In accordance with the terms of the Operating Agreement, each party thereto has the right to take its share of gas produced from the Contract Area and market the same. In the event any of the parties hereto collectively owning participation percentages of less than 50% are not at any time taking or marketing their share of gas or have contracted to sell their share of gas produced from the Contract Area to a purchaser which does not at any time while this agreement is in effect take the full share of gas attributable to the interest of such parties, this agreement shall automatically become effective upon the terms hereinafter set forth.

1. During the period or periods when any parties hereto collectively owning participation percentages of less than 50% have no market for their share of gas produced from any proration unit within the Contract Area, or their purchaser does not take its full share of gas produced from such proration unit, other parties collectively owning participation percentages of more than 50% shall be entitled to produce each month 100% of the lesser of a) allowable gas production assigned to such proration unit; provided, however, no party who does not have gas in place shall be entitled to take or deliver to a purchaser gas production in excess of 200% of the lesser of c) its share of the volumes of gas capable of being delivered on a daily basis or d) its share of allowable gas production. All parties hereto shall share in and own the liquid hydrocarbons recovered from such gas by lease equipment in accordance with their respective interests and subject to the Operating Agreement to which this agreement is attached, but the party or parties taking such gas shall own all of the gas delivered to its or their purchaser.

2. On a cumulative basis, each party not taking or marketing its full share of the gas produced shall be credited with gas in place equal to its full share of the gas produced under this agreement, less its share of gas used in lease operations, vented or lost, and less that portion such party took or delivered to its purchaser. The Operator will maintain a current account of gas balance between the parties and will furnish all parties hereto monthly statements showing the total quantity of gas produced, the amount used in lease operations, vented or lost, the total quantity of liquid hydrocarbons recovered therefrom, and the monthly and cumulative over and under account of each party.

3. At all times while gas is produced from the Contract Area, each party hereto will make settlement with all royalty owners to whom royalty is due. Each party hereto agrees to hold each other party harmless from any and all claims for royalty payments asserted by royalty owners paid by each party. The term "royalty owner" shall include owners of royalty, overriding royalties, production payments and other similar interests.

Each party producing and taking or delivering gas to its purchaser shall pay any and all production taxes due on such gas.

4. After notice to the Operator, any party at any time may begin taking or delivering to its purchaser its full share of the gas produced from a proration unit under which it has gas in place less such party's share of gas used in operations, vented or lost. In addition to such share, each party, including the Operator, until it has recovered its gas in place and balanced the gas account as to its interest, shall be entitled to take or deliver to its purchaser a share of gas determined by multiplying 50% of the interest in the current gas production of the party or parties without gas in place by a fraction, the numerator of which is the interest in the proration unit of such party with gas in place and the denominator of which is the total percentage interest in such proration unit of all parties with gas in place currently taking or delivering to a purchaser.

5. Nothing herein shall be construed to deny any party the right, from time to time, to produce and take or deliver to its purchaser its full share of the allowable gas production to meet the deliverability tests required by its purchaser, provided that said test should be reasonable in length, normally not to exceed 72 hours.

6. If a proration unit ceases to produce gas and/or liquid hydrocarbons in paying quantities before the gas account is balanced, settlement will be made between the underproduced and overproduced parties. In making such settlement, the underproduced party or parties will be paid a sum of money by the overproduced party or parties attributable to the overproduction which said overproduced party received, less applicable taxes theretofore paid, at the applicable price defined below for the delivery of a volume of gas equal to that for which settlement is made. For gas, the price of which is not regulated by federal, state or other governmental agencies, the price basis shall be the price received for the sale of the gas. For gas, the price of which is subject to regulation by federal, state or other governmental authorities, the price basis shall be the rate collected, from time to time, which is not subject to possible refund, as provided by the Federal Energy Regulatory Commission or any other governmental authority, pursuant to final order or settlement applicable to the gas sold from such well, plus any additional collected amount which is not ultimately required to be refunded by such authority, such additional collected amount to be accounted for at such time as final determination is made with respect hereto.

7. Notwithstanding the provisions of $\P6$, it is expressly agreed that any underproduced party shall have the optional right, with respect to each proration unit, to receive a cash settlement bringing such underproduced party's gas account into balance at any time and from time to time prior to the final settlement, by first giving each overproduced party 90 days' written notice of demand for cash settlement. If such option is so exercised, settlement shall be made (as of 7:00 o'clock A.M. on the first day of the calendar month following the date of such written demands) within 90 days following the actual receipt of such written demands by the overproduced parties, in the same manner provided for in $\P6$. The option provided for in this paragraph may be exercised, from time to time, but only one time in each calendar year.

8. Nothing herein shall change or affect each party's obligation to pay its proportionate share of all costs and liabilities incurred, as its share thereof is set forth in the Operating Agreement.

9. This agreement shall constitute a separate agreement as to each proration unit approved by the applicable regulatory authority for a pool within the Contract Area, but such proration unit shall not include any producing horizon which is not within the vertical limits of said pool. This agreement shall remain in force and effect so long as the Operating Agreement to which it is attached remains in effect, and shall inure to the benefit of and be binding upon the parties hereto, their heirs, successors, legal representatives and assigns.

EQUAL EMPLOYMENT OPPORTUNITY PROVISION

During the performance of this contract, the Operator agrees as follows:

- (1) The Operator will not discriminate against any employee or applicant for employment because of race, color, religion, national origin or sex. The Operator will take affirmative action to ensure that applicants are employed, and that employees are treated during employment, without regard to their race, color, religion, national origin or sex. Such action shall include, but not be limited to the following: employment, upgrading, demotion, or transfer, recruitment or recruitment advertising; layoff or termination; rates of pay or other forms of compensation; and selection for training, including apprenticeship. The Operator agrees to post in conspicuous places, available to employees and applicants for employment notices to be provided for the contractcing officer setting forth the provisions of this non-discrimination clause.
- (2) The Operator will, in all solicitations or advertisements for employees placed by or on behalf of the Operator, state that all qualified applicants will receive consideration for employment without regard to race, color, religion, national origin or sex.
- (3) The Operator will send to each labor union or representative of workers with which it has a collective bargaining agreement or other contract or understanding, a notice to be provided by the agency contracting officer, advising the labor union or workers' representative of the Operator's commitments under Section 202 of Executive Order 11246 of September 24, 1965, and shall post copies of the notice in conspicuous places available to employees and applicants for employment.
- (4) The Operator will comply with all provisions of Executive Order 11246 of September
 24, 1965, and of the rules, regulations, and relevant orders of the Secretary of
 Labor.
- (5) The Operator will furnish all information and reports required by Executive Order 11246 of September 24, 1965, and by the rules, regulations, and orders of the Secretary of Labor, or pursuant thereto, and will permit access to its books, records, and accounts by the contracting agency and the Secretary of Labor for purposes of investigation to ascertain compliance with such rules, regulations, and orders.
- (6) In the event of the Operator's non-compliance with the non-discrimination clauses of this contract or with any of such rules, regulations, or orders, this contract may be canceled, terminated or suspended in whole or in part and the Operator may be declared ineligible for further Government contracts in accordance with procedures authorized in Executive Order 11246 of September 24, 1965, and such other sanctions may be imposed and remedies invoked as provided in Executive Order 11246 of September 24, 1965, or by rule, regulation, or order of the Secretary of Labor, or as otherwise provided by law.

Exhibit "F" Page 1 (7) The Operator will include the provisions of Paragraphs (1) through (7) in every subcontract or purchase order unless exempted by rules, regulations, or orders of the Secretary of Labor issued pursuant to Section 204 of Executive Order 11246 of September 24, 1965, so that such provisions will be binding upon each subcontractor or vendor. The Operator will take such action with respect to any subcontract or purchase order as the contracting agency may direct as a means of enforcing such provisions including sanctions for non-compliance: Provided, however, that in the event the Operator becomes involved in, or is threatened with, litigation with a subcontractor or vendor as a result of such direction by the contracting agency, the Operator may request the United States to enter into such litigation to protect the interests of the United States.

Operator acknowledges that it may be required to file Standard Form 100 (EEO-I) promulgated jointly by the Office of Federal Contract Compliance, the Equal Employment Opportunity Commission and Plans for Progress with Joint-Reporting Committee, Federal Depot, Jeffersonville, Indiana, within thirty (30) days of the date of contract award if such report has not been filed for the current year and otherwise comply with or file such other compliance reports as may be required under Executive Order 11246, as amended and Rules and Regulations adopted thereunder.

Operator further acknowledges that he may be required to develop a written affirmative action compliance program as required by the Rules and Regulations approved by the Secretary of Labor under authority of Executive Order 11246 and supply Non-Operators with a copy of such program if they so request.

CERTIFICATION OF NON-SEGREGATED FACILITIES

Operator assures Non-Operators that it does not and will not maintain or provide for its employees any segregated facilities at any of its establishments, and that it does not and will not permit its employees to perform their services at any location, under its control, where segregated facilities are maintained. For this purpose, it is understood that the phrase "segregated facilities" includes facilities which are in fact segregated on a basis of race, color, religion, or national origin, because of habit; local custom or otherwise. It is further understood and agreed that maintaining or providing segregated facilities for its employees or permitting its employees to perform their services at any location under its control where segregated facilities are maintained is a violation of the equal opportunity clause required by Executive Order]1246 of September 24, 1965.

Operator further understands and agrees that a breach of the assurance herein contained subjects it to the provisions of the Order at 41 CFR Chapter 60 of the Secretary of Labor dated May 21, 1968, and the provisions of the equal opportunity clause enumerated in contracts between the United States of America and Non-Operators.

Whoever knowingly and willfully makes any false, fictitious or fraudulent representation may be liable to criminal prosecution under 18 U. S. C. - 1001.
