**VERIFIED STATEMENT OF KEVIN CARTWRIGHT**

Kevin Cartwright, being duly sworn upon his oath, deposes and states:

1. I am a landman for Mewbourne Oil Company, and have personal knowledge of the matters stated herein.

2. Pursuant to Division Rule NMAC 19.15.4.12.A(1), the following information is submitted in support of the compulsory pooling application filed herein:

(a) No opposition is expected because the working interest owners being pooled have been contacted regarding the proposed well, and have simply not decided whether to join in the well or farm out their interests.

(b) A plat outlining the spacing unit being pooled is attached hereto as Exhibit A. Applicant seeks an order pooling all mineral interests from the surface to the base of the Morrow formation underlying the underlying the E/2 of Section 29, Township 22 South, Range 26 East, N.M.P.M., Eddy County, New Mexico, and in the following manner:

(i) the NE/4NE/4 to form a standard 40-acre oil spacing and proration unit for any and all formations or pools developed on 40-acre spacing within that vertical extent, including the Undesignated Happy Valley-Delaware Pool and Undesignated Happy Valley-Wolfcamp Pool;

(ii) the NE/4 to form a standard 160-acre gas spacing and proration unit for any and all formations or pools developed on 160-acre spacing within that vertical extent; and

(iii) the E/2 to form a standard 320-acre gas spacing and proration unit for any and all formations or pools developed on 320-acre spacing within that vertical extent, including the Undesignated Southeast Carlsbad-Wolfcamp Gas Pool,

Undesignated East Hackberry Hills-Canyon Gas Pool, Undesignated South Happy Valley-Atoka Gas Pool, and Happy Valley-Morrow Gas Pool;

The units are to be dedicated to the proposed Huckleberry Draw "29" Com. Well No. 1, to be drilled at an orthodox location in the NE/4NE/4 of Section 29. Also to be considered will be the cost of drilling and completing the well and the allocation of the cost thereof, as well as actual operating costs and charges for supervision, designation of applicant as operator of the well, and a 200% charge for the risk involved in drilling and completing the well.

(c) The parties being pooled, their working interests in the well unit, and their addresses, are as follows:

The above addresses are current and correct.

(d) Copies of the proposal letters sent to the uncommitted working interest owners are attached hereto as Exhibit B. We have also had several telephone discussions and e-mails with these parties, but have been unable to reach agreement with it.

(e) Pursuant to Division rules, applicant requests that a 200% risk charge be assessed against any non-consenting working interest owner.

(f) A copy of the Authority for Expenditure for the proposed well is attached hereto as Exhibit C. The drilling and completion costs set forth therein are fair and reasonable, and are comparable to those of other wells of this depth drilled in this area of Eddy County.

(g) Mewbourne proposes overhead rates (combined fixed rates) of \$7,000 per month while drilling and \$700 per month while producing which are the rates in Mewbourne's February 15, 2010 Operating Agreement that has been signed by McCombs Energy, Ltd. These rates are fair and reasonable, and are in line with rates charged by other operators in this area for wells of this depth. Applicant also requests that the order contain a provision adjusting the rates pursuant to the COPAS accounting procedure.

(h) Applicant requests that it be designated operator of the well.


