



Ladies and Gentlemen:

Enclosed is a copy of an amended application for compulsory pooling, filed with the New Mexico Oil Conservation Division by Devon Energy Production Company, L.P., regarding the E½ of Section 6, Township 23 South, Range 27 East, N.M.P.M., Eddy County, New Mexico. This application is scheduled to be heard at 8:15 a.m. on Thursday, November 20, 2003 at the Division's offices at 1220 South St. Francis Drive, Santa Fe, New Mexico 87505. As an interest owner in the well unit, you have the right to appear at the hearing and present evidence. Failure to appear at the hearing will preclude you from contesting this matter at a later date.

Please note that the Morrow formation underlying the E½ of Section 6 is divided into three zones, with different sets of ownership in each zone. A portion of the Morrow formation is subject to an operating agreement, and a portion is not. Applicant requests pooling of the lower portion of the Morrow formation, which is not subject to an operating agreement. In addition, applicant requests the Oil Conservation Division to approve an allocation of costs and production among the three Morrow zones. This allocation will be binding on all interests owners in the Morrow formation, including those owners subject to the operating agreement.

You are requested to notify, in writing, the Division and the undersigned, by Friday, November 14, 2003, if you intend to enter an appearance and participate in the case.
