

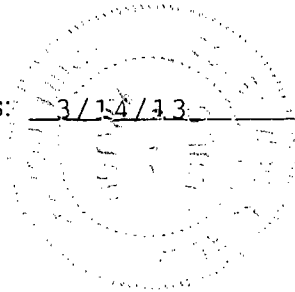
1. I am over the age of 18, and have personal knowledge of the matters stated herein.

5. Applicant has complied with the notice provisions of Division Rules.




