Application of the New Mexico Oil Conservation Division for a Compliance Order against Dennis Langlitz. The Applicant seeks an order revoking Operator's authority to inject into his wells and pursuant to NMSA 1978, Section 70-2-14(B), an order requiring Operator to plug and abandon all the wells he operates in New Mexico and authorizing Applicant to plug and abandon the wells and forfeit the applicable financial assurance in the event of non-compliance.
