**ORDER NO. R-12093**

**PRE-HEARING ORDER**

**BY THE DIRECTOR OF THE OIL CONSERVATION DIVISION AND CHAIR  
OF THE OIL CONSERVATION COMMISSION:**

**THIS MATTER** having come before Lori Wrotenbery, Director of the New Mexico Oil Conservation Division ("the Division") and Chair of the New Mexico Oil Conservation Commission ("the Commission") in connection with the management of the hearing of this matter, and it having become apparent that a Pre-hearing Order is necessary to ensure the orderly presentation of the numerous and complex issues raised by this application, the Director and Chair, being fully advised in the premises, now on this 29th day of January, 2004,

**FINDS** that the Commission has jurisdiction of the parties and that entry of a pre-hearing order is in the best interests of administrative economy and will assist in rendering a complete, coherent and fair consideration of this matter.

**IT IS THEREFORE ORDERED, AS FOLLOWS:**

1. **Hearing before the Commission.** Pursuant to OCD Rule 1216 [19.15.14.1216 NMAC], the Director of the Division hereby directs that this application shall be heard by the Oil Conservation Commission.

2. **Date of Hearing.** A hearing on preliminary legal issues (being the issues raised in Paragraphs 5 and 6 of the Petition ["Petition"] filed by the Valles Caldera Trust), and any objections to the jurisdiction of the Commission, will commence at 9:00 a.m. on Thursday, February 12, 2004.

3. **Place of Hearing.** The hearing will take place in Porter Hall, 1220 S. St. Francis Drive, Santa Fe, New Mexico.


4. **Briefing Schedule.** In order to facilitate the Commission's expeditious consideration of the above-identified preliminary legal issues, the parties shall file briefs addressing these issues prior to the hearing in accordance with the following schedule:

The Petitioner, Valles Caldera Trust shall file its brief in chief no later than 5:00 p.m. on January 30, 2004. Respondent, GeoProducts of New Mexico, Inc. shall file its response no later than 5:00 p.m. on Feb. 6, 2004, and Petitioner may file a reply no later than Feb. 9, 2004. All briefs will be faxed/e-mailed to opposing counsel on the day of filing.

5. **Requests for Oral Argument.** Any request for oral argument on the preliminary legal issues shall be filed with the Respondent's response brief or with the Petitioner's reply brief. Oral argument, if allowed, shall be limited to the preliminary legal issues. Unless the Commission decides to allow oral argument, the hearing shall be limited to responses of counsel to questions from members of the Commission or from Commission counsel regarding the preliminary legal issues.

6. **Pre-Hearing Statements.** Pre-hearing statements shall not be required for this hearing.
