1 CHAIRMAN FESMIRE: The record should reflect
2 that this is the Monday, December 20th, 2010, meeting of
3 the New Mexico Oil Conservation Commission. This
4 meeting is called as a continuance of cases No. 14418
5 and ~~14480~~, and case number 14575.

6 The record should reflect that the Commission
7 has deliberated on these cases and has presented orders
8 to counsel -- I mean, has been presented orders by
9 counsel.

10 We will take Case No. 14418 and the reopened
11 case 14480, the application of Cimarex Energy Company
12 for a non-standard oil spacing unit and compulsory
13 pooling in Eddy County, New Mexico.

14 Have the commissioners had a chance to review
15 the order as presented by counsel?

16 MS. BAILEY: Yes, I have. And I move we adopt
17 it.

18 MR. OLSON: Yes, I've reviewed them. I guess
19 did you figure out what to do for the well main on that?

20 MR. SMITH: Yes. Florene and I checked the
21 application this morning, and, indeed, the 21 needs to
22 be inserted just where you had it.

23 CHAIRMAN FESMIRE: It has been inserted in the
24 copies of the order?

25 MR. OLSON: Except in the cases where it was

1 described in testimony.

2 MR. SMITH: Except for those places that I
3 mentioned in my e-mail to you.

4 CHAIRMAN FESMIRE: There's a motion before the
5 Commission to adopt and sign the order as presented by
6 counsel in Cases No. 14418 and 14480.

7 All those in favor signify by saying aye.

8 MR. OLSON: I'll second that.

9 CHAIRMAN FESMIRE: I'm sorry. There's been a
10 second.

11 All those in favor signify by saying aye.

12 MS. BAILEY: Aye.

13 MR. OLSON: Aye.

14 CHAIRMAN FESMIRE: Aye.

15 Let the record reflect that the order was
16 unanimously adopted. Signed by the commissioners and
17 submitted to the secretary for recording.

18 MR. SMITH: This is the version, Florene, is it
19 not of the pre-order that I e-mailed yesterday?

20 MS. DAVIDSON: Yes.

21 CHAIRMAN FESMIRE: Let the record reflect that
22 the order has been signed and so transmitted.

23 The next matter before the Commission is Case
24 No. 14575, the application of Targa Midstream Services
25 Limited Partnership as operator for Versado Gas

1 Processors, LLC for approval to inject acid gas into
2 Targa's existing Eunice Gas Plant Salt Water Disposal
3 Well No. 1, API No. 30-025-21497, Lea County, New
4 Mexico.

5 Again, an order has been provided by counsel.
6 The commissioners have deliberated. Instructed counsel
7 to draft an order, and that order has been drafted and
8 circulated to the commissioners.

9 Have the commissioners had a chance to review
10 that order?

11 MS. BAILEY: Yes, I have.

12 MR. OLSON: Yes.

13 MS. BAILEY: And I move that we adopt it.

14 MR. OLSON: I'll second that.

15 CHAIRMAN FESMIRE: All those in favor of
16 adopting the said order signify by saying aye.

17 MS. BAILEY: Aye.

18 MR. OLSON: Aye.

19 CHAIRMAN FESMIRE: Aye. Let the record reflect
20 that the order was unanimously adopted by the
21 commissioners. Signed by the commission members and
22 transmitted to the secretary for recording.

24 Commission this morning? The chair seeing none will
25 entertain a motion to adjourn.
