

AMENDED APPLICATION

Mewbourne Oil Company applies for an order (i) abolishing the Seven Rivers-Yeso Pool and the Cemetery-Yeso Pool, (ii) expanding the North Seven Rivers Glorieta-Yeso Pool, and (iii) establishing special rules and regulations for the North Seven Rivers Glorieta-Yeso Pool, Eddy County, New Mexico, and in support thereof, states:

1. The Seven Rivers-Yeso Pool was created by Division Order R-7076, and currently includes the following acreage:

Township 19 South, Range 25 East, N.M.P.M.

Section 26: NW/4

Section 27: E/2

Section 34: All

2. The Cemetery-Yeso Pool was created by Division Order R-7372, and currently includes the following acreage:

Township 20 South, Range 25 East, N.M.P.M.

Section 11: SE/4

3. The North Seven Rivers-Yeso Pool was created by Division Order R-12699, and currently includes the following acreage:

Township 19 South, Range 25 East, N.M.P.M.

Section 22: All

Section 27: NW/4

4. The above pools are developed on statewide rules, which provide for 40 acre spacing, wells to be located no closer than 330 feet to a quarter-quarter section line, and a depth bracket allowable of 80 barrels of oil per day.

5. Applicant is an operator in the above pools.

6. A number of additional wells have been drilled in the above pools, by applicant and other operators, but the pools have not been expanded under the Division's nomenclature proceedings. In addition, the wells in the pools produce from correlative intervals, so there is no need for three separate pools. Therefore, applicant requests the Division to enter an order abolishing the Seven Rivers-Yeso Pool and the Cemetery-Yeso Pool, and expanding the North Seven Rivers Glorieta-Yeso Pool so that it will comprise the following lands:

Township 19 South, Range 24 East, N.M.P.M.

Section 36: SE/4

7. Wells in the above pools being drilled both as horizontal wells and vertical wells, and some wells are capable of producing in excess of the statewide depth bracket allowable without waste or impairment of correlative rights. Therefore, applicant also seeks approval of special pool rules and regulations for the expanded North Seven Rivers Glorieta-Yeso Pool providing for a special depth bracket allowable of 240 barrels of oil per day for a standard 40 acre spacing unit. All other statewide rules will apply.

8. Approval of this application will prevent waste and protect correlative rights.

WHEREFORE, applicant requests that, after notice and hearing, the Division enter its order requesting the relief requested above.
