

CASE 13067: In the matter of the hearing called by the Oil Conservation Division for an order creating and extending certain pools in Chaves and Eddy Counties, New Mexico.

(a) CREATE a new pool in Chaves County, New Mexico classified as a gas pool for Pennsylvanian production and designated as the Bosque-Pennsylvanian Gas Pool (**Pool Code 97263**). The discovery well is the Yates Petroleum Corporation Buder "ACN" Federal Well No. 2 (**API No. 30-005-63513**) located in Unit K of Section 22, Township 6 South, Range 26 East, NMPM.
